#### **PROVINCIAL ELECTRIC CAR INITIATIVES**

#### POWERSTREAM'S "ADVANTAGE POWER" PROGRAM

P. Bursztyn provided an overview of his experience of participating in the Powerstream "Advantage Power" Program. Mr. Bursztyn summarized costing data during off peak, mid-peak and peak hours. He compared Powerstream's pricing structure of the standard program to the "Advantage Power" Program.

- The Nottawasaga Valley Conservation Authority's Board of Directors' approved Resolution recommending that the Nottawasaga Valley Conversation Authority's response to the Conservation Authorities Act Review be approved.
