#### **OPEN DELEGATION BY A REPRESENTATIVE OF ONTARIO MUSICIANS CO-OPERATIVE INC. (OMCI) REGARDING A POSSIBLE PARTNERSHIP WITH THE CITY'S EMERGING ARTIST'S PROGRAM**

A representative of the Ontario Musicians Co-operative Inc. provided an Open Delegation regarding the possibility of partnering with the City's Emerging Artist's Program.

The representative discussed slides concerning the following topics:

- An overview of the Ontario Musicians Co-operative Inc.;
- A chart identifying the Canadian Summer Jobs Grant Funding for Barrie and surrounding areas;
- The logistics associated with the emerging artist partnership proposal;
- The rationale associated with establishing a partnership between the OMCI and the City's 2018 Emerging Artist's Program;
- The responsibilities of the OMCI and the City of Barrie associated with the proposed partnership; and
- How the proposed partnership is in alignment and supports the objectives of the approved emerging artist program.

Members of the Committee asked a number of questions related to the information provided and received responses from the representative and City staff.

Fire Chief Mainprize discussed slides concerning the following topics:

- The organizational structure of the BFES;
- The strategic priorities of the BFES;
- Highlights from the 2017 Annual Report;
- Charts illustrating the following topics:
  - Total incident response and incidents over the past nine years;
  - The percentage increase in incident volumes over the past nine years;
  - The number of incidents by month for the years 2016 - 2017;
  - The six minutes road response percentages between 2010 - 2017;
  - The 2017 percentages of incidents by type;
  - The percentages of incident response types for a five year average versus 2017;
  - The number of incident responses by type for a five year average versus 2016;
  - The number of fires with a dollar loss between 2010 - 2017;
- A map illustrating the location of 2017 fires;
- A chart illustrating the total dollar losses between 2010 - 2017; and
- Future initiatives associated to education, planning, procedure reviews, staff training and support programs.
