Draft 2017 budget expected in September

The board approved guidelines for the development of the draft 2017 NVCA budget. Further, the board approved a series of budget assumptions to help direct the budget development process. The draft budget will be considered by the Board of Directors at their September 23, 2016, meeting.

Conservation Authorities Act Review update

The board received a deputation from Chief Administrative Officer (CAO) Gayle Wood outlining next steps in the provincial *Conservation Authorities Act* Review. The province's stated objective for the review is to "identify opportunities to improve the legislative, regulatory and policy framework that currently governs the creation, operation and activities of conservation authorities."

In May 2016, the province released their proposed priorities in a report entitled, "Conserving our Future – Proposed Priorities for Renewal."

The board approved NVCA's response to these proposed priorities, and directed staff to submit them to the province by September 9, 2016.

Chief Administrative Officer Recruitment

The board approved a CAO recruitment plan and the creation of an ad hoc committee to oversee the process. The committee will include NVCA Chair Doug Lougheed, Vice Chair Gail Ardiel, Past Chair Nina Bifolchi and Board Member Phil Hall. The NVCA board of directors will approve the final CAO selection. It is expected that the new CAO will join the NVCA late May or early June 2017.

In brief

During the meeting the board also:

- approved a municipal service agreement with the Township of Adjala-Tosorontio. This agreement outlines services NVCA will provide to Adjala-Tosorontio regarding applications under the *Planning Act*.
- approved Milestone 1 of the NVCA's Climate Change Strategy Action Plan.
- approved the NVCA's Asset Management Plan for implementation.
- approved a report from NVCA's Director of Planning Services regarding the Province's Four Plan Review and directed staff to provide comments to the province by September 30, 2016. The board also directed staff to prepare a report for their September meeting to enable further discussion on the Niagara Escarpment Commission in the context of the Provincial Plan Review.
- received a staff report outlining the NVCA's accomplishments under Environment Canada's Lake Simcoe South-eastern Georgian Bay Clean-up Fund.
