BY-LAW NUMBER 2016-

A By-law of The Corporation of the City of Barrie to further amend By-law 2014-171 as amended, being a by-law to appoint members to various committees, boards and commissions.

WHEREAS, the Council of The Corporation of the City of Barrie may appoint representatives to various committees, boards and commissions;

AND WHEREAS, By-law 2014-171 was passed on the 15th day of December, 2014 concerning appointments to committees, boards and commissions;

AND WHEREAS, the Council of The Corporation of the City of Barrie adopted motions 16-G-264 to further amend By-law 2014-171 as amended;

NOW THEREFORE, the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** By-law Number 2014-171 as amended be further amended by deleting Schedule "A" and replacing it with Schedule "A" attached hereto, forming part of this by-law.
