# **RECOMMENDED MOTION**

- 1. That the Mayor and Treasurer be authorized to execute a Letter of Agreement with the Province of Ontario as represented by the Ministry of Transportation related to the Dedicated Gas Tax Funds for Public Transportation Program to allow for the alignment of the program year with the Provincial fiscal year.
- 2. That in response to a request from the Province of Ontario as represented by the Ministry of Transportation related to the Dedicated Gas Tax Funds for Public Transportation Program, the City of Barrie reconfirm its commitment to continue to act as the host for the provision of public transit service to the Township of Essa.

# PURPOSE & BACKGROUND

3. The purpose of this report is to execute the Letter of Agreement for the 2016/17 Provincial Gas Tax and to reconfirm the City of Barrie's commitment to continue to act as the host for the provision of public transit service to the Township of Essa.

# ANALYSIS

- 4. Staff have recently received the Provincial Gas Tax information and agreement for 2016/17 which require a supporting by-law and for the agreement to be executed.
- 5. The Provincial government has committed to supporting municipal transit by the allocating annual funding to these municipalities for the sole purpose of improving transit through the Provincial Gas Tax (PGT) Program.
- 6. The contribution that the City of Barrie will receive has increased over the 2015/16 levels by \$27,900 (from \$2,031,232 to \$2,059,132).

9. The PGT funding is currently fully allocated to the operating budget with a draw of \$2,090,000 anticipated for 2017. The uncommitted balance in the PGT reserve (11-05-0595) as of December 31, 2016 is projected to be \$182K.
