BY-LAW NUMBER 2017-

A By-law of The Corporation of the City of Barrie to permanently close the soil and freehold described as Teck Road (not travelled), Plan 51M-867, City of Barrie.

WHEREAS Section 8 of the *Municipal Act*, 2001, S.O. 2001, c. 25 (the "Act"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS pursuant to Section 34 of the *Municipal Act*, the Council of every Municipality may pass by-laws to permanently close a highway;

AND WHEREAS Teck Road (not travelled), Plan 51M-867, City of Barrie is no longer required for highway purposes;

AND WHEREAS the Council of The Corporation of the City of Barrie adopted Motion 16-G-275.

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts the following:

- 1. **THAT** Teck Road (not travelled), Plan 51M-867, City of Barrie, being all of PIN 58763-1437(LT), be and is hereby permanently closed.
- 2. **THAT** the City Clerk be authorized to execute all documents necessary to carry out the intent of this by-law.
- 3. **THAT** this By-law will have effect upon registration in the Land Registry Office of Simcoe County.
- 4. **THAT** Schedule "A" to this By-law, being an Affidavit of Carly Pearce, sworn on February 28, 2017 forms a part of this By-law.
