Deputy Chief Carlson provided an overview of the March 2017 statistics. Calls for service were up 7.6% for the month compared to March 2016. Eighty-eight percent of the 5,614 calls for service were non-crime incidents.

3. New Board Letterhead

Members approved the proposed new Board letterhead to reflect the change in the Service's letterhead as a result of the corporate branding initiative.

4. <u>Project Lifesaver</u>

Mayor Lehman advised that the Barrie Chamber of Commerce has endorsed Project Lifesaver, a program that gives out ankle bracelets which emit a radio frequency. They would be worn by people with Dementia, Alzheimer's, etc. Georgian Bay Search and Rescue have asked for a meeting. Chief Greenwood advised that the Barrie Police Service is supportive of this initiative and could have a representative attend the meeting.

5. <u>Justice Tulloch Report Overview</u>

Received for information was a Report on the Justice Tulloch Independent Police Oversight Review. Justice Tulloch had been charged with reviewing Ontario's three civilian oversight bodies (Special Investigations Unit, Office of the Independent Police Review Director and the Ontario Civilian Police Commission) and released his report March 31, 2017.
