LOCATION; 140 Lockhart Road
consisting of 93.34 acres.

ACCESS: Mapleview Drive and south on Whelham Road which extends onto the property as a cul-de-sac with water and sewers. Whelham Road is planned to be extended through the Lockhart farm as a major north south route.

Lockhart Road according to the Salem Secondary Plan is to be widened to five lanes from Hwy 400 to Huronia Road including the railway bridge. Both of these routes would give easy access to the property.

HISTORY; This property was short-listed to the final three possible choices for a city park when Sid Armitage was Director of Parks & Rec. This property lost out to the site that was chosen on land owned by the Ontario government in Midhurst.

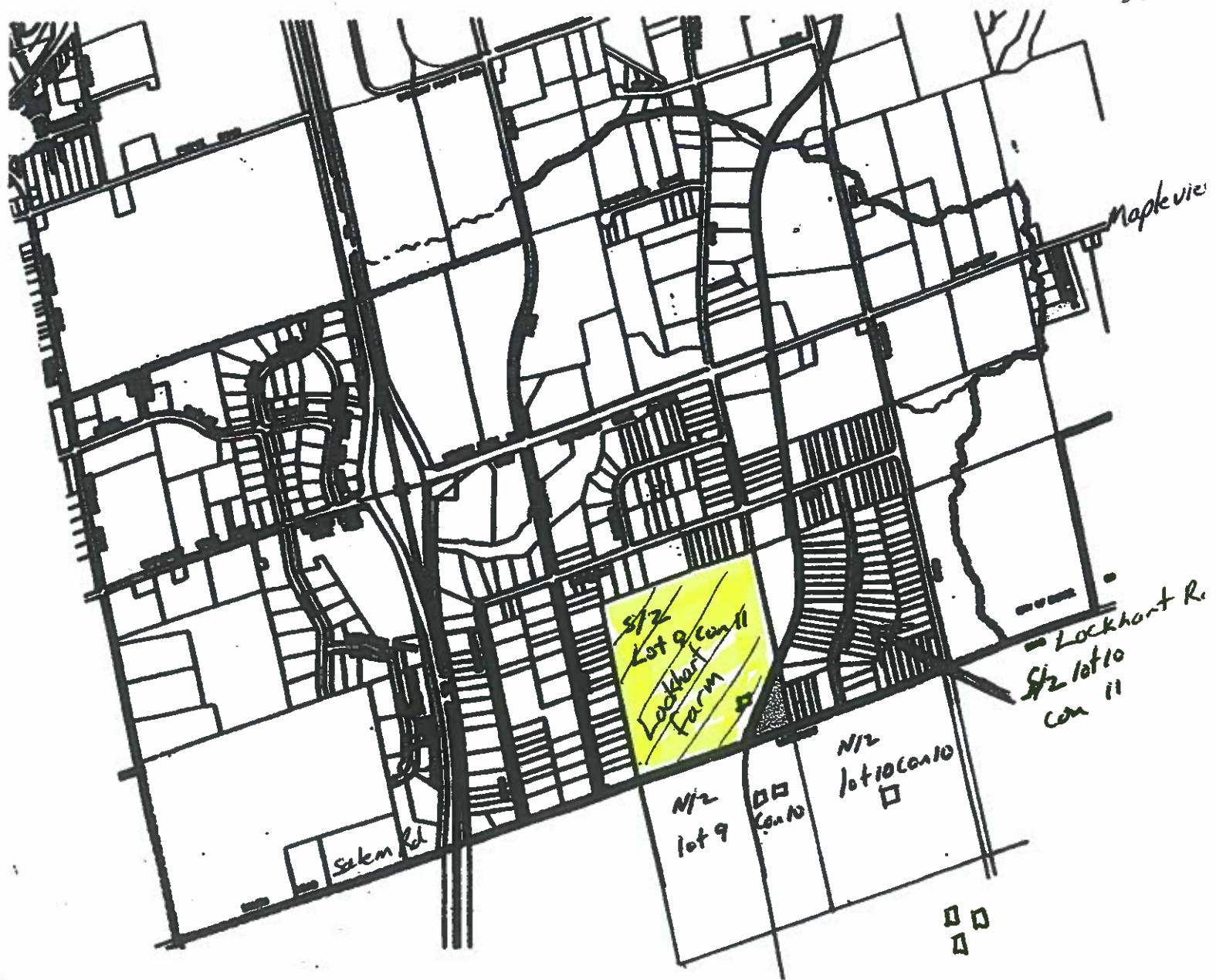
BENEFITS; This property is surrounded by the South Barrie Industrial Park and has industrial zoning with no noise or light restrictions. The property will be easily accessible from Mapleview Drive or Lockhart Road. This property, with 93 acres provides enough land for multiple sports uses, such as baseball park, football stadium, and many soccer pitches and any other sports desired. This site could also be used for concerts, as Molson Park was in the past.

We ask that this site be considered for the much needed sports park for the City of Barrie.

MUNICIPAL CLASS ENVIRONMENTAL ASSESSMENT, PHASES 3 & 4**

NOTICE OF COMPLETION

The Corporation of the City of Barrie has completed a Schedule "C" Municipal Class Environmental Assessment (Class EA) to determine the Preferred Design for transportation improvements in the Salem Secondary Plan Area, as recommended in the City's Multi-Modal Active Transportation Master Plan.

The transportation improvement projects considered in the Class EA include the following:

- a) Salem Road, Veterans Drive to CR 27
- b) Lockhart Road, Highway 400 east limits to Huronia Road, including a grade separated rail crossing
- c) Essa Road, Maplevue Drive to CR 27
- d) Veterans Drive, Salem Road to City limits
- e) Huronia Road, Lockhart Road to City limits
- f) McKay Road West, CR 27 to Highway 400 west Limits
- g) McKay Road East, Highway 400 east limits to Huronia Road

The planning and decision-making process used to determine the Preferred Design for the above listed projects is documented within an Environmental Study Report (ESR). The ESR is available for public review for a thirty (30) calendar day period, ending on November 11, 2017.
