RECOMMENDED MOTION

- 1. That the following proposed Municipal Street Names and identified in Appendix "A" to Staff Report PLN002-19 for the Plan of Subdivision in the Yonge GO Subdivision, be approved:
 - a) Street A Westwood Avenue;
 - b) Street B Turnberry Lane;
 - c) Street C Gateway Drive;
 - d) Street D Fairlane Avenue;
 - e) Street E Haven Lane;
 - f) Street F Evergreen Terrace;
 - g) Street G South Park Lane; and
 - h) Street H and I Highgate Avenue.

PURPOSE & BACKGROUND

Report Overview

2. Staff Report PLN028-18 was presented to Council on December 17, 2018 to approve the Municipal Street Names for the Yonge GO Subdivision. It was requested that the Planning and Building Services Department investigate the feasibility of replacing the proposed street names of "Haven Lane" with "Spooner Street and "North Lawn Heights" with "Evergreen Terrace" and report back to General Committee.

ANALYSIS

- 3. The proposed street names to be replaced as requested by Council were circulated to external and internal departments for commenting.
- 4. Concerns were raised regarding Spooner Street for the reason that there is an existing similar street name in a surrounding municipality that would cause confusion for emergency services and therefore Spooner Street cannot be used. Haven Lane remains the recommended street name.

ALTERNATIVES

7. The following alternative is available for consideration by General Committee:

<u>Alternative #1</u>: General Committee could reject the recommended motion and request that the applicant provide a new or revised list of street names for the subdivision.

This alternative is not recommended as street names are required to begin the municipal addressing processes and the proposed list meets all requirements of the street naming policy. Restarting the circulation process would delay the emergency addressing process significantly.
