Tom Reeve, Senior Infrastructure Planning Program Coordinator provided a presentation concerning an overview on the Drainage Master Plan.

T. Reeve discussed slides concerning the following topics:

- An overview of the Infrastructure Master Plans;
- An illustration identifying the areas where the Infrastructure Master Plans will be utilized;
- The rationale associated with the requirement for a Drainage Master Plan;
- A flow chart summarizing the five phases of the Municipal Class EA Planning and Design Process;
- The definitions of Lot Level and Linear Low Impact Developments (LID) including the benefits and limitations;
- Information associated with conveyance improvements associated to channels, culverts and storm sewers;
- Information associated with existing and new stormwater ponds;
- Opportunities to implement bio-retention facilities and infiltration galleries within existing and new parks and stormwater ponds;
- A map indicating 200 drainage project locations within the City;
- The key findings of the Drainage Master Plan Review; and
- The next steps of the Drainage Master Plan project and after the completion of the Drainage Master Plan.
