NOTICE OF AN OFFICIAL PLAN AMENDMENT AND AMENDMENT TO THE ZONING BY-LAW AND NOTICE OF A PUBLIC MEETING PURSUANT TO SECTIONS 17(15) AND 34(12) OF THE PLANNING ACT, R.S.O. 1990, AS AMENDED, IN RESPECT TO A PROPOSED OFFICIAL PLAN AMENDMENT AND AMENDMENT TO THE ZONING BY-LAW.

Re: Official Plan Amendment and Amendment to the Zoning By-law – PIVAG c/o Pranav Chauhan, 45 & 51 Penetang Street, Barrie.

TAKE NOTICE that the General Committee of the Council of the Corporation of the City of Barrie will hold a public meeting on **Monday**, **April 15**, **2019 at 7:00 p.m**. in the Council Chambers of City Hall, 70 Collier Street, to review an application for an Official Plan Amendment and Amendment to the Zoning By-law submitted by Innovative Planning Solutions c/o Amiee Powell on behalf of PIVAG c/o Pranav Chauhan for lands known municipally as 45 and 51 Penetang Street, Barrie.

The applicant is proposing to Create a new Defined Policy Area on Schedule C to permit a maximum density of 186 u/ha.

The applicant is also proposing to amend the current zoning of the property from C4 (General Commercial) and RM2 (Residential Multiple Dwelling Second Density) to 'Residential Apartment Dwelling First Density-2 - Special Provision (RA1-2-SP)' with seven special provisions to permit the development of a 5-storey Residential Apartment Building.

Any person may attend the meeting and make representation or present submissions respecting this matter. If you wish to make a submission concerning this matter it should be directed to Legislative and Court Services by **Tuesday**, **April 09**, **2019**. Any person may make representation at the meeting, however, written submissions are encouraged. Notification of the Official Plan Amendment and Amendment to the Zoning By-law if adopted by Council will be provided upon written request to the City Clerk.

If a person or public body does not make oral submissions at the public meeting or make written submissions to the Corporation of The City of Barrie before the Official Plan Amendment and Amendment to the Zoning By-law is passed:

- (a) the person or public body is not entitled to appeal the decision of the Corporation of The City of Barrie to the Local Planning Appeal Tribunal; and
- (b) the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If you wish to be notified of the decision of the Council of The Corporation of the City of Barrie in respect of the proposed Official Plan Amendment and Amendment to the Zoning By-law, you must make a written submission to the undersigned and the Planning and Building Services Department.

All information including opinions, presentations, reports, documentation, etc. provided for or at a Public Meeting are considered public records.
