17-A-005 PRESENTATION REGARDING THE BARRIE PUBLIC LIBRARY BOARD'S PROPOSED 2017 BUDGET REQUEST

Mr. Ray Duhamel, Chair of the Barrie Public Library Board provided a presentation concerning the Barrie Public Library Board's 2017 Budget Request. Mr. Duhamel introduced Mr. Marc Saunders, CEO of the Barrie Public Library, members of Barrie Public Library staff and the members of the Barrie Public Library Board who were present.

Mr. Duhamel discussed slides concerning the following topics:

- Highlights of the budget request including the Library's strengths and strategic directions;
- The value of the library services provided, the successes of the Barrie Pubic Library and the challenges that are being experienced;
- A graph illustrating the circulation per active cardholder in comparison to other Ontario municipalities; and
- An overview of the 2017 municipal operating grant request.

In closing Mr. Duhamel summarized the 2017 Budget request and discussed the increase over the 2016 Budget.

Members of City Council asked a number of questions of Mr. Duhamel and Mr. Saunders concerning the information presented and received responses.

Mr. Trevor Wilcox, General Manager of Corporate Performance, Ms. Jane Sinclair, General Manager of Health and Emergency Services and Mr. Greg Bishop General Manager of Social and Community Services of the County of Simcoe provided a presentation concerning the 2017 County of Simcoe Budget Request.

- The highlights of the Health and Emergency Services 2017 Capital Budget.

Mr. Bishop discussed slides concerning the following topics:

- An overview of the Social and Community Services provided;
- The 2016 accomplishments and the 2017 key initiatives / focus areas associated with Ontario Works;
- The 2016 accomplishments and the 2017 key initiatives / focus areas associated with Children and Community Services;
- The 2016 accomplishments and the 2017 key initiatives / focus areas associated with Social Housing;
- The highlights of the Social and Community Services 2017 Operating Budget; and
- The highlights of the Social and Community Services 2017 Capital Budget.

Mr. Wilcox discussed slides concerning the following topics:

- A chart illustrating operating and capital budget changes between 2014 to 2017 for services provided by the County of Simcoe to the City of Barrie; and
- A chart illustrating the 2016 Capital Budget in comparison to the 2017 Capital Budget request.

Chief Greenwood provided a presentation concerning the Barrie Police Service 2017 Operating and Capital Budget request.

Chief Greenwood discussed slides concerning the following topics:

- The highlights of the 2017 to 2019 Strategic Business Plan;
- A chart summarizing the Barrie Police Service complement for the period of 2011 to 2021;
- Current and future initiatives and programs;
- A chart summarizing the 2016 Operating Budget in comparison to the 2017 Operating Budget request;
- A summary of the sources of operating expenditures and decreases reflected in the budget request;
- The costs associated with operating the Police Service facilities and details related to the First Responders Campus;
- A pie graph illustrating sources of grants and revenue;
- A summary of the Capital Budget request; and
- The proposed new capital initiatives.

In closing, Chief Greenwood thanked the members of the Barrie Police Services Board, the Barrie Police staff and the citizens who make the Service strong and safe. She requested approval of the municipal funding portion of the Barrie Police Service 2017 Budget request.
