The Heritage Barrie Committee met and reports as follows:

#### **SECTION "A"**

#### COUNTY OF SIMCOE ARCHAEOLOGICAL MANAGEMENT PLAN

G. Marek, Manager of Planning from the County of Simcoe provided a presentation concerning the County of Simcoe's Archaeological Management Plan (AMP).

Mr. Marek discussed slides concerning the following topics:

- An overview on the County of Simcoe's AMP;
- The Legislation and Policy Direction associated to the AMP;
- A description of an Archaeological Potential Model;
- Historical information associated to the potential model of Indigenous sites;
- Background Information associated to the potential model for historical sites;
- An overview on when to apply an archaeological potential planning layer;
- Revisions to the County's policies and procedures;
- The Indigenous communities engagement in the AMP;
- A map illustrating the First Nation Treaty Lands;
- The AMP Steering Committee;
- The public consultation process;
- The County's endorsement of the AMP;
- The Archaeological potential mapping resources; and
- The next steps for the AMP.

The Committee asked a number of questions to Mr. Marek and received responses.

#### **COMMITTEE BUDGET UPDATE**

C. Froese provided an update on the Committee's 2020 Budget. The Committee discussed purchasing promotional items such as a tablecloth with a map, historical games, books for display purposes and name tags for Committee members during Heritage Barrie events.

The Committee approved the expenditure of funds not to exceed \$200.00 for the costs associated to the purchase of promotional items from the Heritage Barrie Committee Account 1025 500400.

#### **DEBRIEF 2019 HERITAGE BARRIE AWARDS**

The Committee provided feedback regarding the 2019 Heritage Barrie award ceremony held at City Council on December 16, 2019. The Committee provided suggestions to improve on for future award ceremonies. The Committee discussed the possibility of changing the date of future Heritage Barrie award ceremonies to coincide with Heritage Week that takes place annually during the month of February.

The Committee agreed to discuss the item at a future meeting.

T. Wierzba, Planner provided an update regarding the 2020 Work Plan. The Committee discussed and provided their feedback to Mr. Wierzba related to the 2020 Work Plan

#### **2020 HERITAGE WEEK**

The Committee discussed the preparations for 2020 Heritage Week events including a proclamation and a presentation to City Council to be held on February 10, 2020.

C. Froese, Vice-Chair advised that the 2020 Heritage Week is scheduled for February 17 to 23, 2020. He noted that he is currently working on the presentation material and will provide an update at the next meeting. Mr. Froese highlighted that he has booked a table at the Barrie Farmer's Market on February 15, 2020 to promote Heritage Week.

#### STATUS OF POTENTIAL LISTINGS MUNICIPAL HERITAGE REGISTRAR

T. Wierzba, Planner provided an update regarding the status of potential listings to Municipal Heritage Registrar. Mr. Wierzba provided the Committee with an updated list of the Municipal Heritage Registrar. The Committee decided to focus on the institutional buildings listed on the Registrar.

The Committee agreed to add the Cenotaph and the Military Heritage Park located at 205 Lakeshore Drive to the Municipal Heritage Registrar as listed properties.
