BY-LAW 2011-

A By-law of The Corporation of the City of Barrie to permanently close the soil and freehold described as Part of Lot 7, Plan 13, designated as Part 2 on Plan 51R-23619, City of Barrie, being all of PIN 58815-0259 (LT).

WHEREAS Section 8 of the Municipal Act, 2001, S.O. 2001, c. 25 (the "Act"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS pursuant to section 34 of the Act, the council of every municipality may pass by-laws to sell the soil and freehold of part of a permanently closed highway, and to set the sale price of the land to be sold;

AND WHEREAS the Council of The Corporation of the City of Barrie adopted Motion 11-G-128;

AND WHEREAS Part of Lot 7, Plan 13, designated as Part 2 on Plan 51R-23619, City of Barrie, being all of PIN 58815-0259 (LT) is no longer required for highway purposes.

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT** Part of Lot 7, Plan 13, designated as Part 2 on Plan 51R-23619, City of Barrie, being all of PIN 58815-0259 (LT), be and hereby is permanently closed.
2. **THAT** the Mayor and the Clerk be authorized to execute all documents necessary to carry out the intent of this by-law.
3. **THAT** this By-law will have effect upon registration in the Land Registry Office of Simcoe County.
4. **THAT** Schedule "A" to this By-law, being an Affidavit of Karen Ball, sworn June 24, 2011 forms a part of this by-law.

READ a first and second time this 27th day of June, 2011.

READ a third time and finally passed this 27th day of June, 2011.
