

**BY-LAW NUMBER 2014-**

**A By-law of The Corporation of the City of Barrie to amend By-law 89-86 being a by-law to designate private roadways as Emergency Fire Routes along which no parking of vehicles shall be permitted.**

**WHEREAS**, pursuant to the Fire and Protection Act, 1997, S.O. 1997, C.4, s.7.1.(1)(c) the Council of any municipality may designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted;

**AND WHEREAS**, the Council of The Corporation of the City of Barrie adopted By-law 89-86 being a by-law to designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted;

**AND WHEREAS**, by motion 05-G-514, it is deemed expedient that the Council of The Corporation of the City of Barrie amend By-law 89-86, as amended, being a by-law to designate private roadways as emergency fire routes along which no parking of vehicles shall be permitted.

**AND WHEREAS** Section 8 of the Municipal Act, 2001, provides that the power of a municipality shall be interpreted broadly so as to confer broad authority on municipalities to enable municipalities to govern its affairs as it consider appropriate and, to enhance the municipality's ability to respond to municipal issues;

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** By-law 89-86 be amended by adding Schedule 239 attached hereto as Schedule "A" designating an emergency fire route at 149 Live Eight Way (Park Place – LA Fitness)
2. **THAT** By-law 89-86 be amended by adding Schedule 240 attached hereto as Schedule "B" designating an emergency fire route at 204 Alva Street (Patterson Place Residences)
3. **THAT** By-law 89-86 be amended by adding Schedule 241 attached hereto as Schedule "C" designating an emergency fire route at 72 The Queensway (Hyde Park Public School)
4. **THAT** By-law 89-86 be amended by adding Schedule 241 attached hereto as Schedule "D" designating an emergency fire route at 31, 41, 43, 45, 47, 49, 51, 53, 55, 57 Ferndale Drive South (SCC376 Manhattan)
5. **THAT** By-law 89-86 be amended by adding Schedule 243 attached hereto as Schedule "E" designating an emergency fire route at 831 Big Bay Point Road (1779926 Ontario Inc)
6. **THAT** By-law 89-86 be amended by adding Schedule 244 attached hereto as Schedule "F" designating an emergency fire route at 221 Harvie Road (SSCC390 Southwoods)
7. **THAT** By-law 89-86 be amended by adding Schedule 245 attached hereto as Schedule "G" designating an emergency fire route at 504 Big Bay Point Road (Bibles for Missions)
8. **THAT** By-law 89-86 be amended by deleting Schedule 168 and replacing it with Schedule "H" attached hereto designating an emergency fire route at 132 Edgehill Drive (Waterford Retirement Community)
9. **THAT** By-law 89-86 be amended by deleting Schedule 86 and replacing it with Schedule "I" attached hereto designating an emergency fire route 201 Georgian Drive (Royal Victoria Regional Health Centre)
10. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 28th day of April, 2014.

**READ** a third time and finally passed this 28th day of April, 2014.

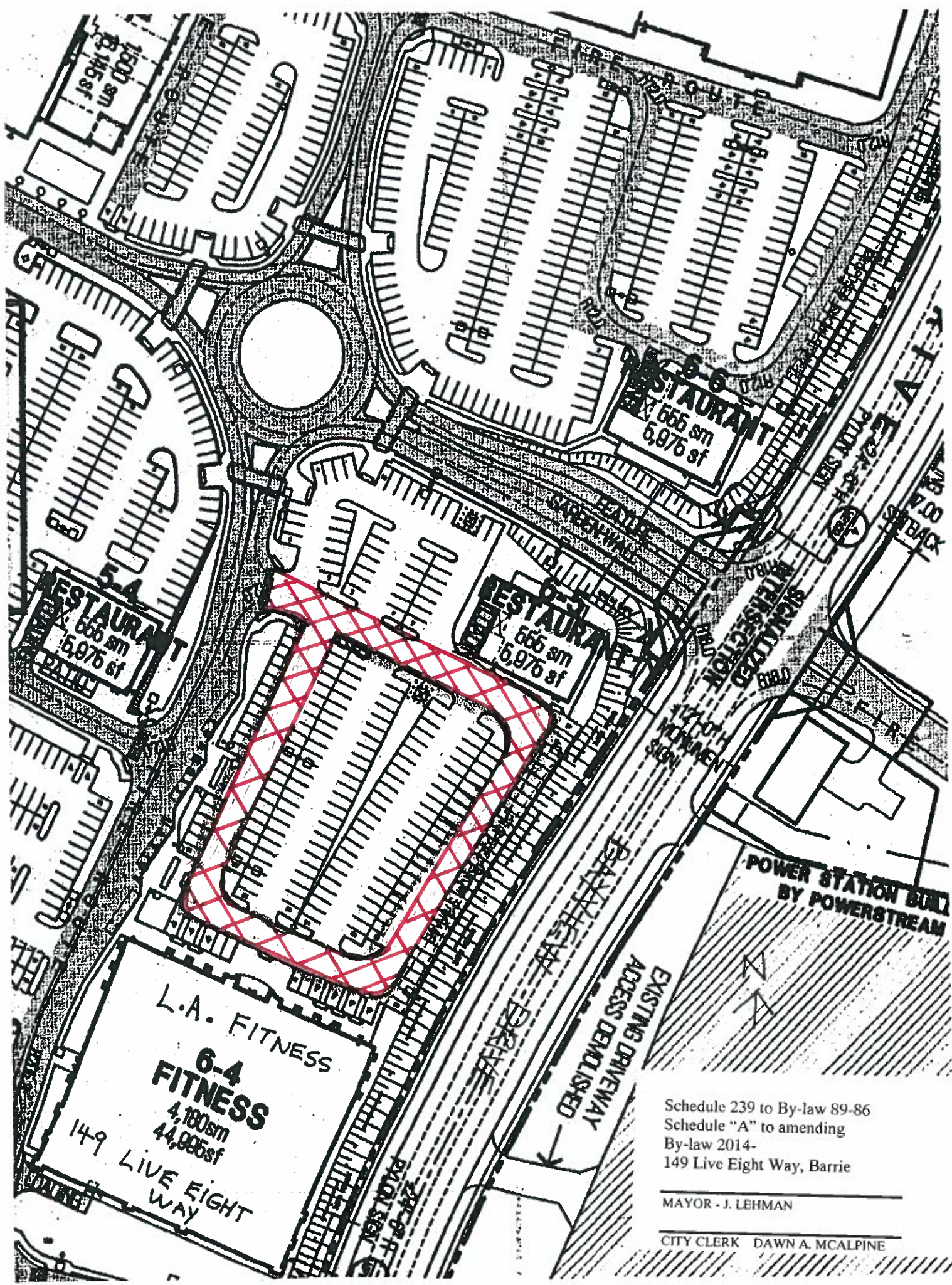

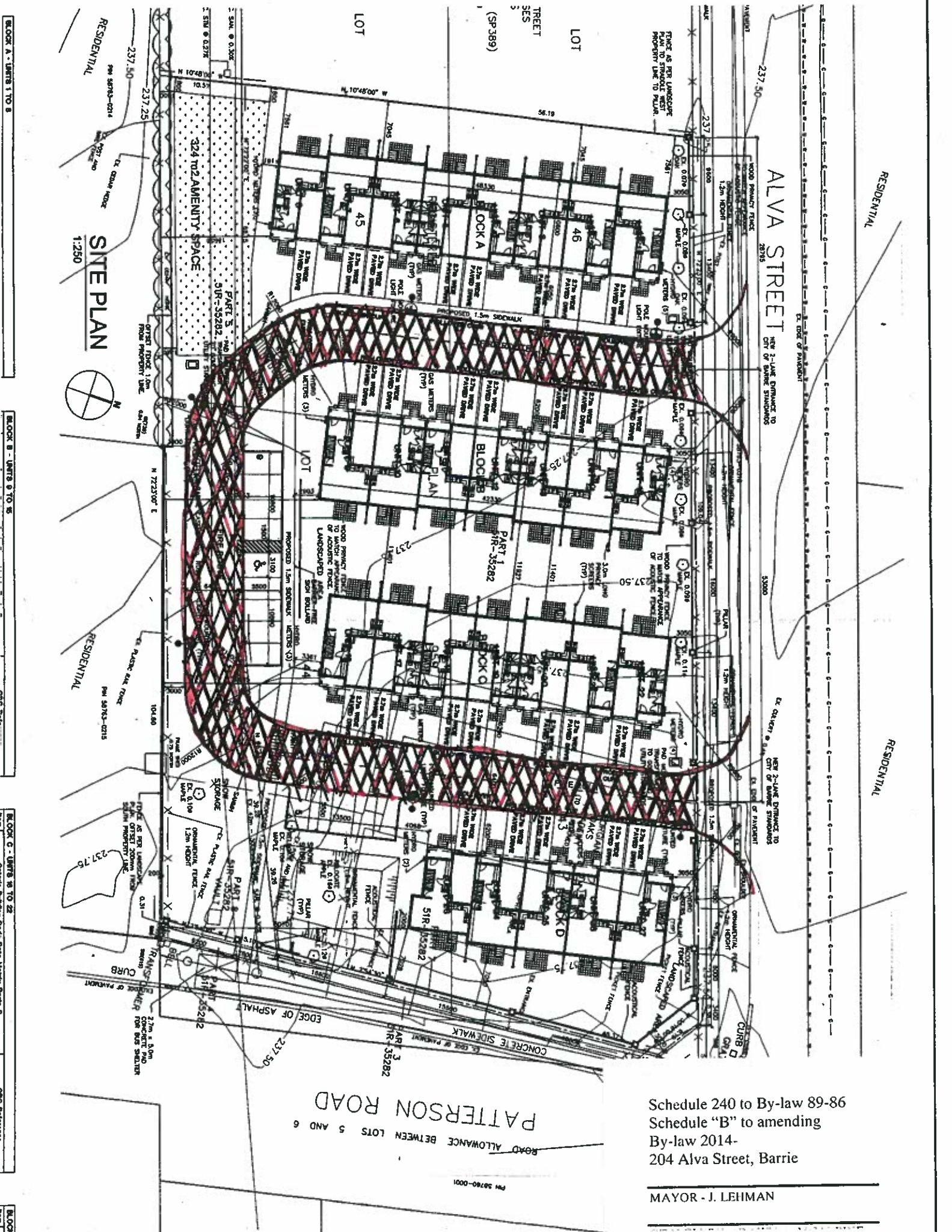

BLOCK C - UNITS 17 TO 22

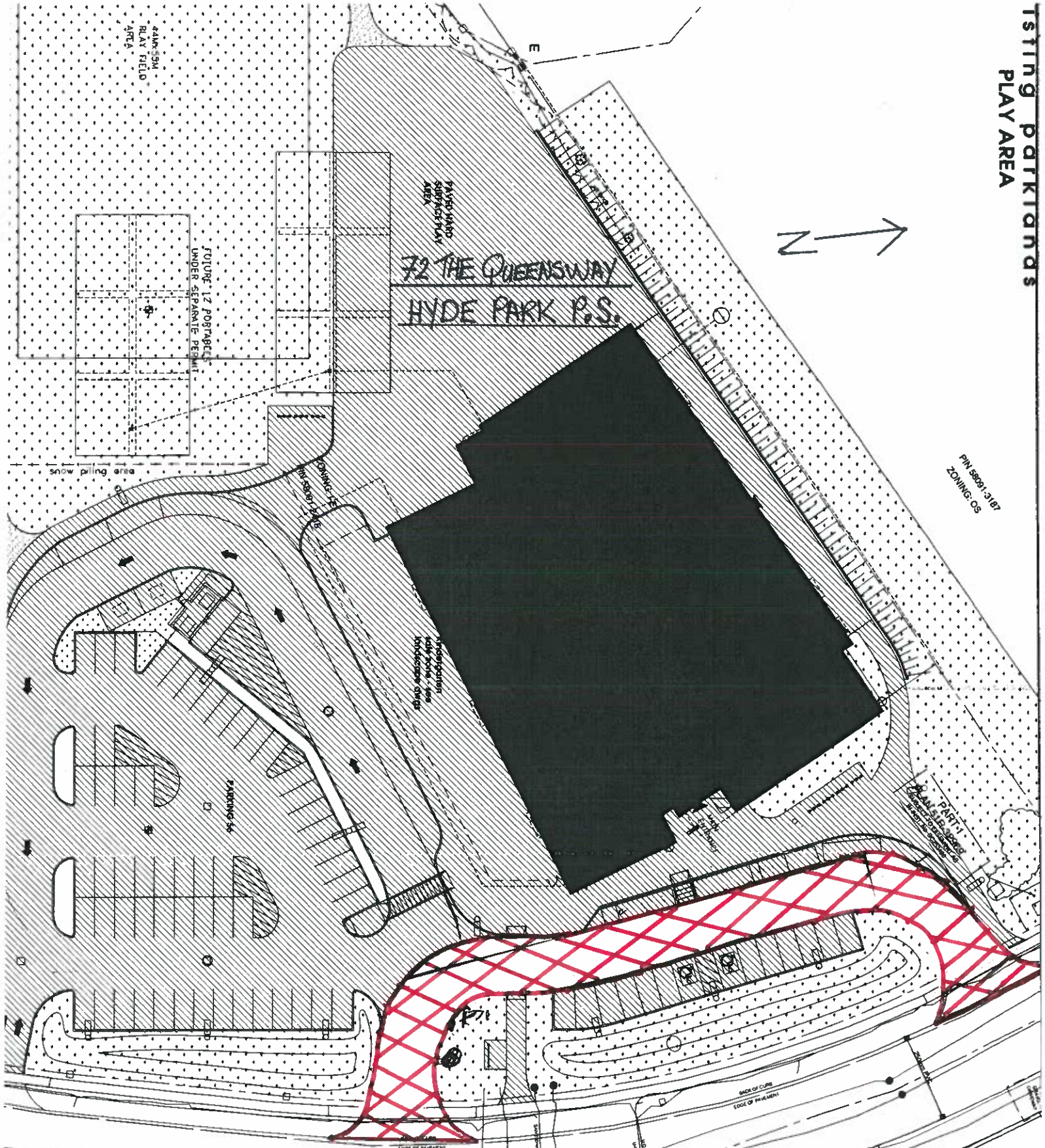

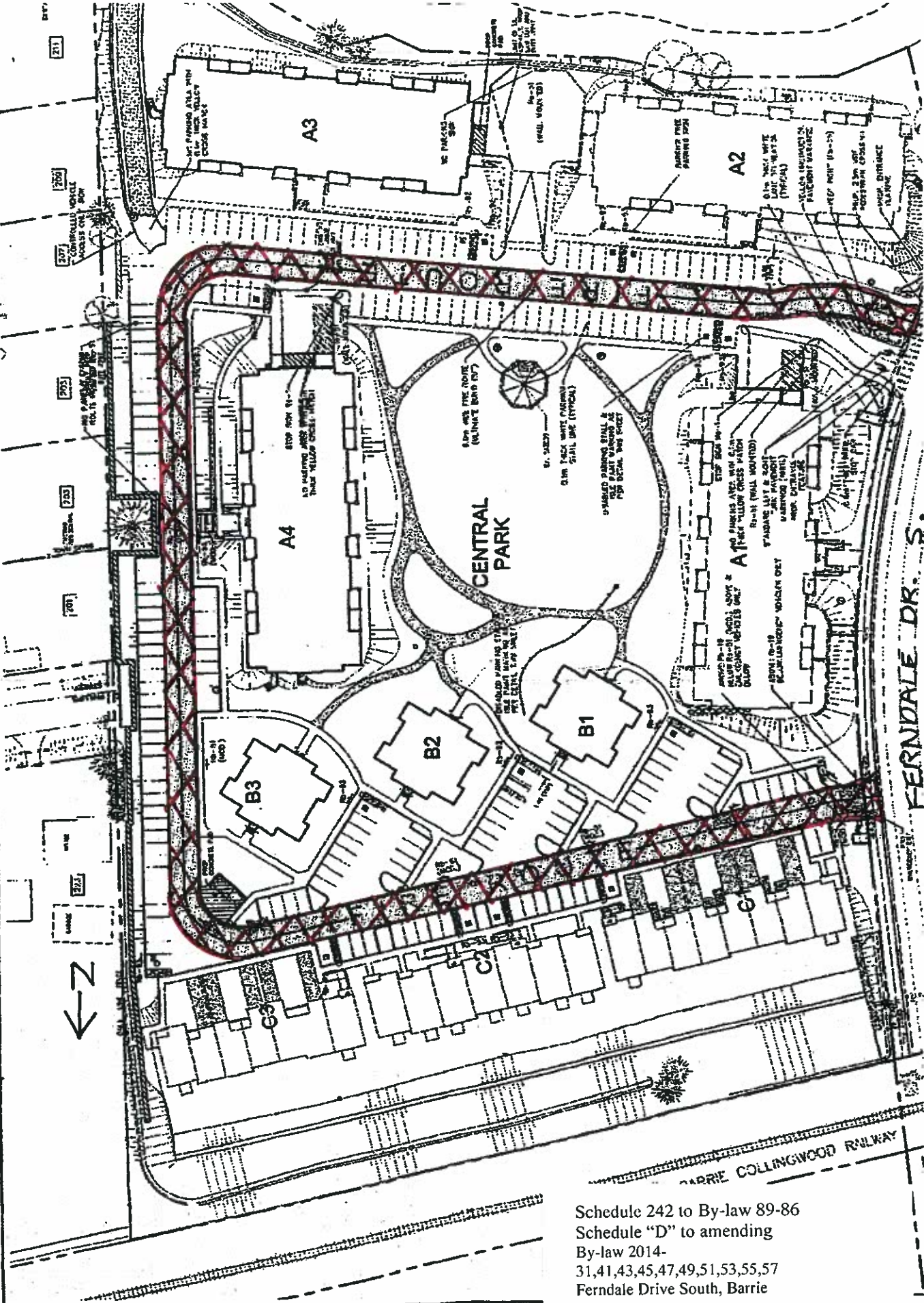

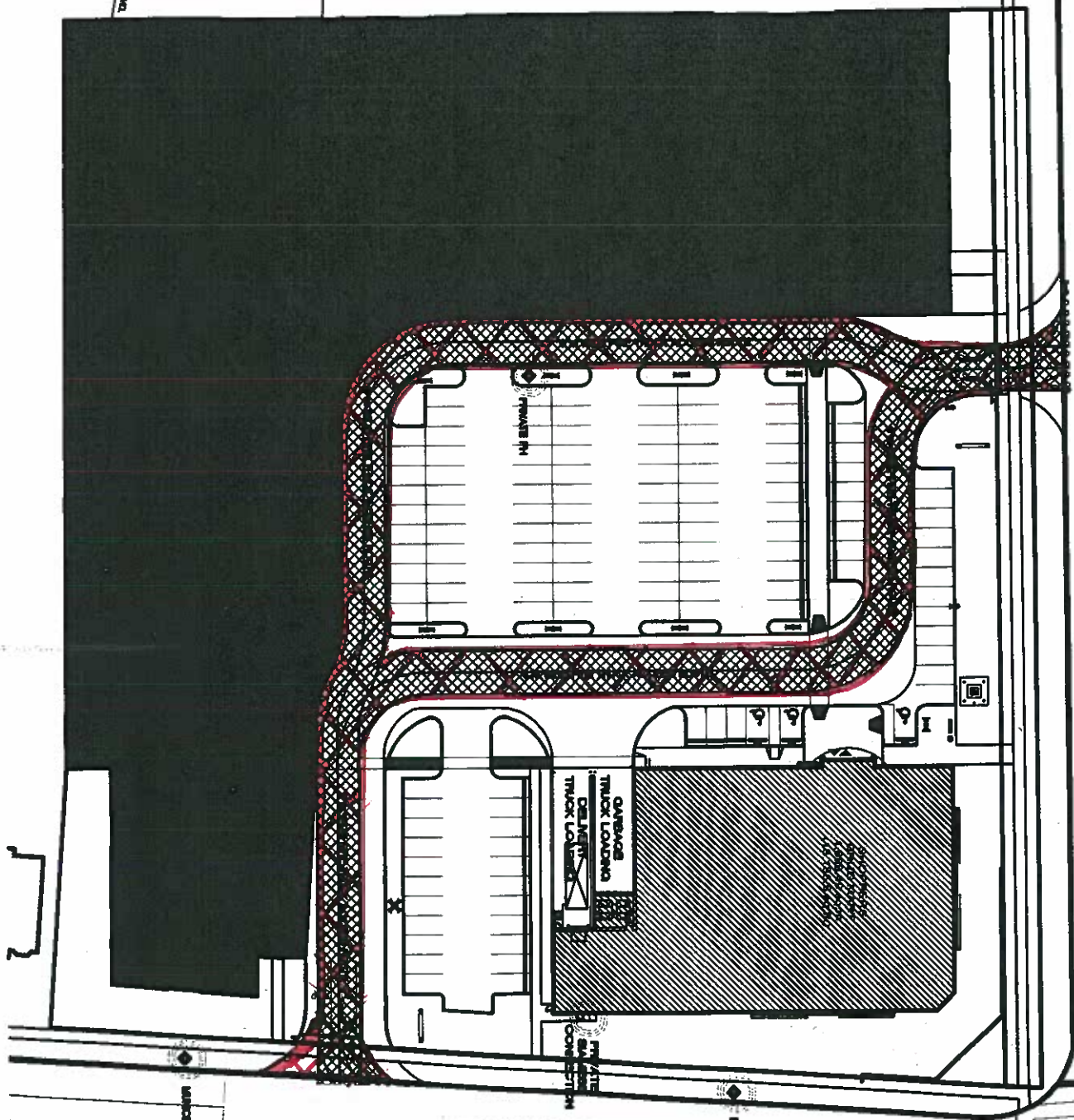
SIGNALIZED INTERSECTION

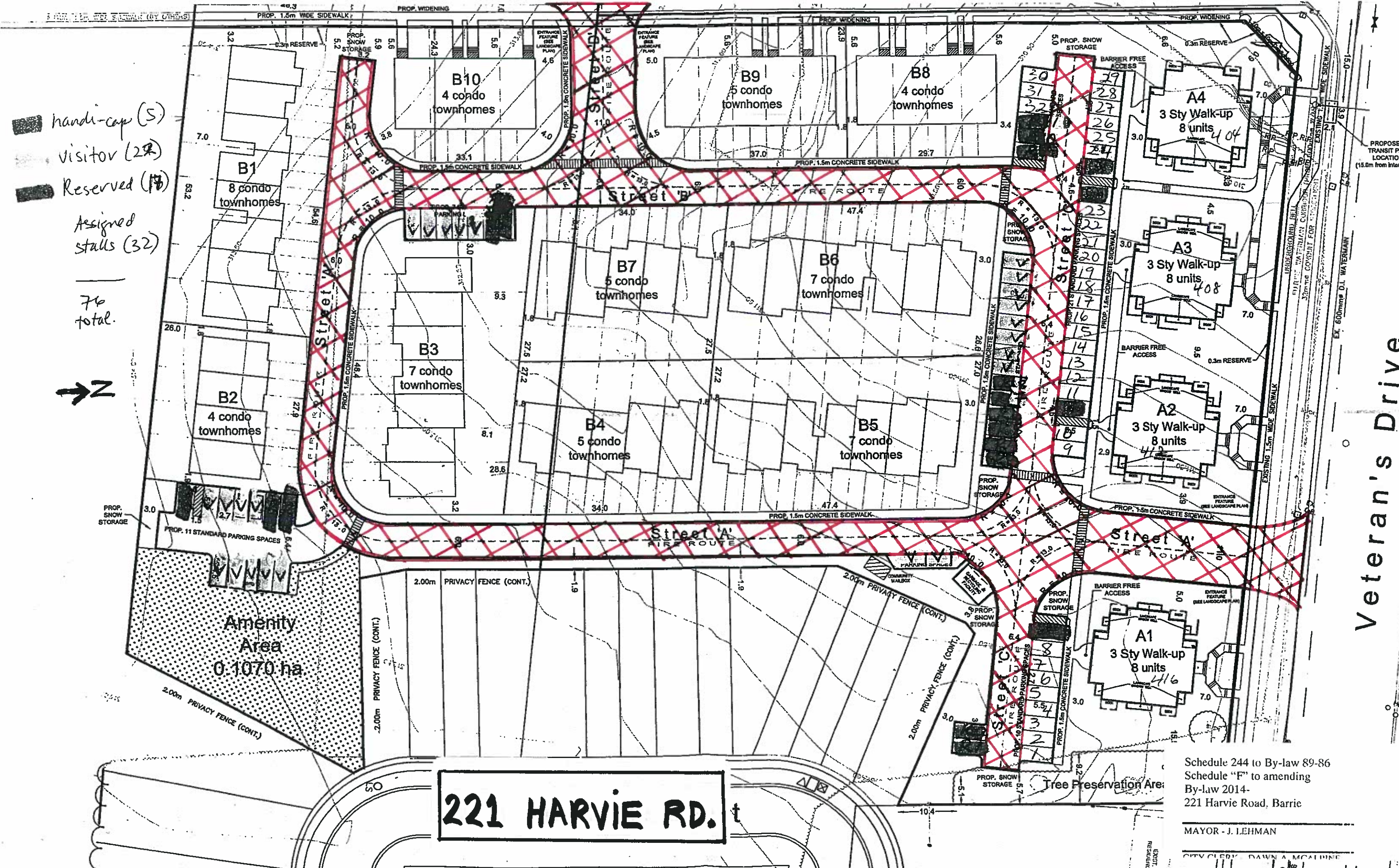
