Mr. S. Feeney identified himself to the Chair and explained he was acting on behalf of the Issuer of Licences for the City of Barrie.

Mr. S. Feeney requested an exclusion order from the Committee with respect to the second witness on behalf of 1748215 Ontario Inc., Mr. C. Iftikhar.

The Committee approved the request to exclude the second witness on behalf of 1748215 Ontario Inc. from the Council Chamber before evidence was presented.

Ms. C. Fernandes identified herself to the Chair and advised that she was acting on behalf of the Applicant, Mr. R. Iftikhar of 1748215 Ontario Inc.

Ms. T. Banting, Municipal Law Enforcement Supervisor and Issuer of Licences was sworn in by W. Sutherland, Committee Secretary. Mr. S. Feeney presented evidence and examined Ms. T. Banting as a witness.

A Member of the Committee requested clarification of the evidence provided by Ms. T. Banting.

Ms. C. Fernandes cross-examined Ms. T. Banting with respect to the evidence that had been provided.

Mr. S. Feeney examined Ms. T. Banting in reply.

Ms. C. Fernandes cross-examined Mr. B. Keene with respect to the evidence that had been provided.

Ms. C. Fernandes examined Mr. R. Iftikhar in reply.

Ms. C. Fernandes provided closing statements on behalf of the Applicant.

2011 AUDITED CONSOLIDATED FINANCIAL STATEMENTS

1. That the 2011 Audited Consolidated Financial Statements be approved.
2. That the expense resulting from setting up an allowance in relation to the MacLaren Art Centre notes receivable of \$3,941,141 be funded as follows:
 - a) \$1,970,571 from the Tax Capital Reserve (13-04-0440)
 - b) \$1,970,570 from the Tax Rate Stabilization Reserve (13-04-0461)
3. That in the event any future funds are recovered related to the allowance for the MacLaren Art Centre notes receivable, the funds be allocated to the Tax Capital Reserve (13-04-0440) and the Tax Rate Stabilization Reserve (13-04-0461).
4. That staff in the Legal Department investigate and report to General Committee by memorandum concerning the following:
 - a) That the City in making this accounting adjustment, does not change its place in line for recompense during any possible creditor claims if the MacLaren Art Centre is forced into bankruptcy after the 10 year period (2016);
 - b) The possibility of obtaining the Spirit Catcher as a City asset in exchange for monies owed and before the possibility of the MacLaren Art Centre being forced into bankruptcy in 2016; and
 - c) That the City building that houses the MacLaren Art Centre is and will be held safe from harm in 2016. (File: F03)
