The Accessibility Advisory Committee met and reports as follows:

DISCUSSION BY DON GREEN REGARDING INVISIBLE DISABILITIES

D. Green and L Duncan, Simcoe Community Services discussed invisible disabilities and the challenges that Mr. Green faces throughout the community due to his cerebral palsy. Mr. Green and Ms. Duncan were concerned there is not enough education in the Community about invisible disabilities. They also commented that they will be working with Cerebral Palsy Association and Simcoe Community Services to promote education.

The Committee agreed that something needs to be done to educate the Community on invisible disabilities.

C. Dillon, Accessibility Co-ordinator suggested that the International Day of Persons with Disabilities would be a great forum to educate the public about invisible disabilities. She also suggested using Barrie Transit as a venue to promote and communicate awareness about invisible disabilities.

Mayor J. Lehman agreed and suggested that the Accessibility Advisory Committee work with Communication staff to develop an advertising campaign for Barrie Transit about invisible disabilities.
