County of Simcoe Written Pledge

Dear Minister Calandra,

The County of Simcoe, like other communities across Ontario, has a significant number of people who are experiencing homelessness. The County of Simcoe's Housing & Homelessness Services team is working tirelessly every day to support people experiencing homelessness, who are unsheltered or who are staying in temporary shelters, to move to permanent housing. The announcement of the top-up to the Canada-Ontario Housing Benefit (COHB) will further increase the positive flow of individuals toward permanent housing.

Throughout 2024, the County of Simcoe has invested significantly in four modular facilities so that it could create more space in the shelter system to access rapid rehousing programming and, in turn, permanently free up much-needed shelter beds for those living outside. The recent announcement for One-Time Shelter Expansion / Encampment Response Initiative Funding under the Homelessness Prevention Program (2024-2025) aligns perfectly with the County's 10-Point Homelessness strategy (attached) and its most recent efforts to bring people living in encampments inside through its rapid rehousing modular facilities.

Please accept this letter as a written pledge of our continued commitment to support unsheltered individuals living in encampments and in shelters to successfully transition to safe and stable housing and our commitment to continue to optimize the use of shelter spaces by ensuring effective flow in the system.

We appreciate the enhanced funding to help us address this ongoing challenge.
