

# Boardwalk - Capital Budget

- Cost estimate \$750,000
- DC component is 24%
- Funding options
  - Fund from TCR
    - reduce reserve balance
    - increase contribution to maintain planned balance
  - Issue more debt
  - Defer other projects



### Boardwalk – Maintenance Costs

- Design will consider lifecycle costs
- Minimize maintenance costs
- Current boardwalk 15 years
  - Spot board replacements
  - \$50,000 renewal



### Boardwalk - Schedule

- Boardwalk is at 60% design
- Approvals required
- We do not anticipate impact to current tender schedule (March)



# Vision: Opportunities for Economic Development



## Kiosks – Servicing

 Lakeshore Contract 3 will provide upgraded servicing for water/sanitary/electrical within the park for connection to kiosks



# Kiosks – Concept Design





- Concept above is for the Marina it is a modified and fit-out shipping container that is serviced (hydro & water), insulated, heated and cooled for all year-use



### Kiosks – Costs

- Cost estimate for Marina design is \$30K to \$35K
- Facilities staff are investigating modifying this design to reduce the cost per unit for future locations and companies that specialize in this type of unit (currently all overseas)
- Shifting portions of the cost to future licensees (e.g. interior fit-up, signage) would reduce City's cost



# Kiosks – Current Waterfront Business Partnerships & Opportunities

There are presently (4) types of commercial opportunities at the Waterfront:

### 1. Marina commercial slips:

- E.g. Sailing charters, wakeboarding, sailing school
- Agreements in process for 2016 through the Marina

#### 2. Concessions

- Ice cream at Marina and Centennial Beach concession
- Agreements extended for 2016



# Kiosks – Current Waterfront Business Partnerships & Opportunities

There are presently (4) types of commercial opportunities at the Waterfront:

### 3. Specialized services

- E.g. Hot air Balloons extended for 2016
- New tandem bicycle rental and horse drawn carriage pilots in discussions for 2016

### 4. Land-based waterfront opportunities

- Stand Up Paddleboarding at Centennial Beach and Heritage Park working on extended agreement with the addition of canoe & kayak lessons/rentals
- RFP to be issued to the market in early 2016 for additional services and locations



## Next Steps

### Boardwalk

Motion in 2016 Budget Staff Report

#### Kiosks:

- RFEI to market in March 2016 to assess interest and solicit input from businesses on program
- Staff Report to Council prior to summer recess to summarize results of RFEI, recommend locations and numbers, propose agreement type/term, capital & operating costs, phasing/pilot recommendations, and next steps
- Upon approval of program by Council issue RFP to market in the Fall 2016 for the 2017 season and commence kiosk manufacture/acquisition
