Patrick Harrington of Aird & Berlis LLP provided a Deputation on behalf of Pattison Outdoor concerning a request for an exemption to Sign By-law 2018-029, section 12.1.4.1.5 to permit a poster panel sign for the property municipally known as 335 Bayfield Street, Barrie.

Mr. Harrington discussed slides concerning the following topics:

- The background associated with the Application for a ground sign/poster panel sign;
- An aerial photograph illustrating the location of 335 Bayfield Street and the surrounding area;
- The required setbacks for a poster panel sign identified in the Sign By-law in relation to the Application;
- The Sign By-law definition of a poster panel sign;
- An aerial photograph illustrating City staff's position related to setback from roof signs;
- The Sign By-law definition of prohibited signs;
- City staff's position associated with the classification of roof signs;
- Provisions of the Sign By-law associated with poster panel signs;
- The definition of minor variance in the Sign by-law and how the deputant believes it applies to the application; and
- A summary of the Application the deputant believes and the request for an exemption.

Members of Council asked questions to City staff and received responses.

following matter, as he is representative of the Progressive  
Conservative Party for Barrie-Spring-Water-Oro-Medonte. He did not  
participate or vote on the mater. He left the Council Meeting.**

Pursuant to Section 4(16) of Procedural By-law 2013-072, Council considered additional emergency deputation requests by Bonnie North, Darren Roskam, Hillary Chase, Edward Moll, Tanya Lynn Hobson, and Morgan Cope in opposition to motion 19-G-172, Report of the Integrity Commissioner dated May 22, 2019. Upon a vote of Council being taken the additional emergency deputations were not permitted to address City Council.

Deputations regarding motion 19-G-172, Report of the Integrity Commissioner dated May 22, 2019 by the following:

1. Victoria Butler expressed her disappointment and frustration concerning the Council's decision to not permit the additional Emergency Deputations to address Council concerning the Report of the Integrity Commissioner. She provided details concerning her

experiences of growing up in Barrie, and the society she lives in today. She commented on the changes in diversity and safety within the City. Ms. Butler discussed her views concerning Councillor Aylwin's Facebook post associated to racism, white supremacists, and hate crimes. She advised that she felt that Councillor Aylwin's post in no way implied that the two Members of Parliament (MP) were racist and that she felt his intention was for them not to stay silent on these issues facing society and that the MPs had misinterpreted the post. Ms. Butler noted her concerns with certain members of Council having personal ties to one of the MPs and indicated that she felt that they should have removed themselves from the discussion of this item as she felt that there would be a bias. Ms. Butler advised that Barrie is changing and becoming a more diverse City and she felt that society won't be able to grow if we don't support and take a stand against hatred. Ms. Butler asked that Council to make the right decision for the City and take a look at the bigger picture and the future of the City. She noted as she believes that and we need to stand up to hate and implored Council to rethink the recommendation of General Committee on this matter.

2. Adam Ballah discussed his opinions concerning the quality of the Integrity Commissioner's Report. He specifically referred where he felt that Ms. Craig erred in the interpretation of sections 5 and 20 of the Code of Conduct concerning whether or not an MP can be defined as members of the public. He noted that he felt sections 5 and 20 did not apply to the statements made by Councillor Aylwin on his Facebook post and questioned the Integrity Commissioner's rationale in the report. Mr. Ballah addressed his concerns associated with a statement made by MP Brassard thanking members of Council for their support prior to the Council's decision on the matters. He asked that Council reconsider their position on this matter.
3. Dr. Anita Arvast advised that she felt that there was an incredible bipartisanship going on. She commented that in her opinion the Facebook post did not say the MPs were racists or white supremacists, only that the MPs were silent on the matter. Dr. Arvast noted that she felt that there has been a tight timeline for Councillor Aylwin to manage the defamation suit and respond to the Integrity Commissioner's Report. Dr. Arvast mentioned that Councillor Aylwin was willing to meet with MP Brassard to try and work out a solution, but that MP Brassard refused to meet with him. Dr. Arvast discussed her concerns related the perception associated with the partisan conflicts with the MPs. She suggested that Council seek legal counsel prior to approving a reprimand.
4. Donna Douglas noted that she has had interactions with MPs Nuttall and Brassard as well as Councillor Aylwin and has no axe to grind. She expressed her concerns surrounding this matter and that it has proven to be an unfortunate process. She advised of her personal



experiences growing up and she noted that she had people to look up to that allowed her to grow and excel to become the person she is today. Ms. Douglas noted that in this situation Council should consider pulling together and provided an example of the community coming together when the tornado ripped through Barrie. Ms. Douglas asked that Council put aside political opinion and noted that our city will be better for it.

5. Sheetal Rawal advised she is a lawyer, acting on her own behalf, and that she is not providing legal advice on this matter. She noted that this matter could be subject to a judicial review so that this process should be dealt fairly and responsibly. Ms. Rawal discussed her views on what the role and the function of the Integrity Commissioner should be. She spoke about bias and conflict of interest related to a May 23, 2019 press release by the complainant. Ms. Rawal commented that in her opinion the Integrity Commissioner's position was based on the wrong interpretation of who are members of the public. She noted that Members of Parliament should not be considered as members of the public as they are elected officials. Ms. Rawal noted that she felt the Integrity Commissioner's Report is unhelpful and limited to the rules within the Code of Conduct. She commented that she felt that there needs to be reasonable limits associated with the Charter of Rights and Freedom for people to speak freely and noted that this should be safe guarded. Ms. Rawal noted that Council should proceed with caution on this matter. She indicated that she did not accept the findings of the Report.
6. Mayor Lehman called upon Michael Speers to provide a deputation. Michael Speers was not present to provide the deputation.
7. Louise Gravelle, advised that she read the Integrity Commissioner's Report. She indicated that she felt that MPs Brassard and Nuttall have lend their power to silence to Councillor Aylwin. She noted that she has issues with the interpretation contained within the Integrity Commissioner's Report concerning of the breaches the Code. She questioned the reference in the Code of Conduct concerning a member of public and commented that she felt that it does not apply to MP Brassard. Ms. Gravelle commented that she does not believe the post was accusatory towards the MPs and that Councillor Aylwin was only suggesting to them to not stay silent on the matter. She raised concerns associated with two member of Council vying for MP position. She commented that it comes down to the interpretation of content of the Integrity Commissioner's Report, and noted that in her mind this situation should never had reach the point where it is today.
8. Bernie Farber provided a background on the Canadian Anti-Hate Network noting it is an independent, nonprofit organization made up of Canada's leading experts and researchers on hate groups and hate crimes. He praised Councillor Aylwin for taking a stand in

challenging leaders to speak out about these types of issues in times like these. Mr. Farber provided details on other experiences that he had through the Network. He noted that this is not a political issue but that he felt that is a matter of defending our fellow Canadians. He commented that the MP should have engaged with Councillor Aylwin directly. Mr. Farber requested members of Council to speak out for the well-being of the vulnerable and to engage in a dialogue, as silence is no longer an option.

9. Mohammed Hashim on behalf of Urban Alliance on Race Relations provided his opinions on the issues ahead ourselves as a Canadian Nation and the need to stand together. He commented on the unfortunate fact that we live in a dangerous time and we need to stand united. Mr. Hashim discussed that he felt that the two items from the post were misinterpreted and determined to be hateful. He discussed his personal experiences as a result of the New Zealand Massacre and the memories that still stay with him today. He advised that he has seen violence and that he was concerned that it is happening in his own native land. Mr. Hashim discussed the need for politicians to speak up to be heard. He commented on his understanding of MP Brassard's point of view and he felt that the post must have meant something to MP Brassard to cause him to feel the way he did. He expressed his opinions associated for the need for better stability in politics and acknowledged that is why there is Code Conduct. Mr. Hashim provided his comments associated with Council approving the reprimand based on the Integrity Commissioner's Report and he acknowledged that either decision is a lose-lose discussion that will set the tone. He discussed the impact that this matter has had on the community. He asked that members of Council defer consideration of the Report to give to him time to work with the parties to find a solution.
