### **OPEN DELEGATION BY MICHAEL SLINGER CONCERNING THE 2021 TO 2024 COMMUNITY SAFETY WELL-BEING PLAN**

Michael Slinger provided an open delegation concerning the 2021 to 2024 Community Safety and Well-Being Plan. Mr. Slinger provided a handout with a list of questions related to the Community Safety Well-Being Plans for 2021 to 2024 and 2025 to 2028, and City staff will follow up with a response.

Mr. Slinger commented on the various local neighbourhood associations such as Allandale Neighbourhood Association. He described the difficulty engaging with the community engagement about City initiatives, and that he felt that each ward should have neighbourhood meetings to provide updates.
