RECOMMENDED MOTION

1. That Rates of Speed By-law 2002-191, Schedule "B", 'Authorized Rates of Maximum Speed – Variable Time Flashing 40 km/h Zone', be amended to include the designated times at which the speed limit is in effect as identified in Appendix "A" to Staff Report DEV038-23.

PURPOSE & BACKGROUND

- Staff in the Development Services Department recommend amending the Rates of Speed By-law 2002-191, Schedule "B" 'Authorized Rates of Maximum speed – Variable Time Flashing 40 km/h Zone' to include the designated time at which the speed limit is effective and is a requirement of the Highway Traffic Act.
- 3. There are currently 23 Variable Time Flashing 40 km/h Zones with the City. In accordance with the Highway Traffic Act, these zones are located within 150 metres along a roadway in either direction beyond the limits of the school property.
- 4. The Council approved Policy requires Variable Time Flashing 40 km/h Zones to be installed on collector roadways with a daily traffic volume greater than 5,000 vehicles per day. The prescribed times are determined based on the arrival, dismissal and nutrition break schedule of the affected schools. Listed below are the criteria used to determine the flashing time period for each of the three time periods of each weekday during the school year:
 - a) 30 minutes prior to morning arrival bell and 15 minutes after.
 - b) 15 minutes before and after nutrition break.
 - c) 15 minutes prior to dismissal bell and 30 minutes after.

ANALYSIS

5. In reviewing the existing Rates of Speed By-law 2002-191, Schedule "B" 'Authorized Rates of Maximum Speed – Variable Time Flashing 40 km/h Zone', it was determined that the prescribed times at which the speed limit is effective are not included within the existing Rates of Speed

By-law 2002-191. Under the Highway Traffic Act, there is a requirement that the prescribed times are to be identified in the Rate of Speed By-law.

6. Based on investigations and research, Staff recommend that the following amendments are to be made to the Rate of Speed By-law 2002-191:

That Rates of Speed By-law 2002-191, Schedule "B", 'Authorized Rates of Maximum Speed – Variable Time Flashing 40 km/h Zone', be amended as attached in Appendix "A" to Staff Report DEV038-23 to include the designated times the variable flashing 40 km/h zones will be in effect.

7. Barrie Police Service do not oppose the recommendation.

ALTERNATIVES

9. The following alternative is available for consideration by General Committee:

Alternative #1

General Committee could maintain the existing Rates of Speed By-law 2002-191, Schedule "B" 'Authorized Rates of Maximum Speed – Variable Time Flashing 40 km/h Zone' (i.e. Status Quo)

This alternative is not recommended as it is a requirement under the Highway Traffic Act to include the designated time at which the speed limit is effective.
