BY-LAW NUMBER 2016-

A By-law of The Corporation of the City of Barrie to appoint a Risk Management Official and Risk Management Inspector for the purpose of the Clean Water Act, 2006.

WHEREAS Section 8 of the *Municipal Act, 2001*, S.O. 2001, c.M.25 (“the *Municipal Act, 2001*”), provides that the powers under *Municipal Act, 2001* shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality’s ability to respond to municipal issues;

AND WHEREAS Section 9 of the *Municipal Act, 2001*, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS Section 10 of the *Municipal Act, 2001*, provides that a single-tier municipality may pass by-laws respecting matters within the spheres of jurisdiction set out therein;

AND WHEREAS, pursuant to Section 227, of the *Municipal Act, 2001*, it is the role of the officers and employees of the municipality to implement council’s decisions and establish administrative practices and procedures to carry out council’s decisions; to undertake research and provide advice to council on the policies and programs of the municipality and to carry out other duties as required under this or any Act and other duties assigned by the municipality;

AND WHEREAS subsection 47(1)(a) of the *Clean Water Act, 2006* provides that a municipality that has authority to pass bylaws respecting water production, treatment and storage under the *Municipal Act, 2001* is responsible for the enforcement of Part IV of the *Act* in the municipality;

AND WHEREAS subsection 47(6) of the *Clean Water Act, 2006* provides that a municipality that is responsible for the enforcement of Part IV of the *Act* shall appoint a risk management official and such risk management inspectors as are necessary for that purpose;

AND WHEREAS by motion 05-G-475 and 12-G-254 the Council of The Corporation of the City of Barrie deems it expedient to pass a by-law to appoint a Risk Management Official and Risk Management Inspector;

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts as follows:

1. **THAT** Katie Nicole Thompson be appointed as a Risk Management Official and Risk Management Inspector in accordance with subsection 47(6) of the *Clean Water Act, 2006*, as amended for the City of Barrie for the term of her employment as a Risk Management Official.
2. **THAT** Sherry Lynn Diemert, Manager of Infrastructure Planning be appointed as an alternate Risk Management Official and Risk Management Inspector in accordance with subsection 47(6) of the *Clean Water Act, 2006*, as amended for the City of Barrie for the term of her employment as a Manager of Infrastructure Planning.
3. **THAT** this By-law shall come into force and effect immediately upon the passing thereof.

READ a first and second time this 11th day of January, 2016.

READ a third time and finally passed this 11th day of January, 2016.
