The Seniors and Accessibility Advisory Committee met and reports as follows:

#### **MULTI-YEAR ACCESSIBILITY PLAN**

Karen Cooper, Manager of Health and Safety reviewed the 2019-2024 Multi-Year Accessibility Plan with the committee. Karen highlighted that there have been some structure changes within the organization and those changes will be updated within the document. Karen sought feedback from the committee with respect to any area's members wanted updated. Committee members asked questions relating to what projects the city has currently undertaken that relate to seniors and accessibility, and if there are any upcoming projects that need the committee's input. Karen will connect with Development Services with respect to any upcoming projects and report back to the committee. Karen advised that a new Multi-Year Accessibility Plan needs to be created before the end of 2024. Karen and the Chair will connect offline to initiate the work that needs to be done on the Accessibility Plan. The committee asked Karen to bring a presentation regarding the new proposed Multi-Year Accessibility Plan to the next committee meeting.

## **PUBLIC CONSULTATION SURVEY**

Karen Cooper, Manager of Health and Safety, reviewed the Age and Accessibility Public Consultation Survey with the committee. Members provided the following feedback:

- Removing the insufficient housing question on page five and updating it to include a question relating to purpose-built housing versus conversion housing;
- Adding a question around accessibility buttons and their locations/usage;
- Adding a question around ageism and if that has an affect on Senior's finding jobs; and
- Updating a few of the main question titles.

Chair, Councillor Nigussie, asked that a question be included to ask if members of the public feel safe going downtown and to the local city parks. Cheri Harris, Associate Director of Communications and Customer Service advised that the goal is to have the survey go live in September. Karen and Cheri agreed to bring back a final draft version to the committee for review before publishing for people to complete.
