BY-LAW NUMBER 2024 -

A By-law of The Corporation of the City of Barrie to establish 0.30M Reserve Block 196, Plan 51M-1257, City of Barrie, County of Simcoe being all of PIN: 58727-2126 (LT), 0.30M Reserve Block 197, Plan 51M-1257, City of Barrie, County of Simcoe being all of PIN: 58727-2127 (LT), 0.30M Reserve Block 198, Plan 51M-1257, City of Barrie, County of Simcoe being all of PIN: 58727-2128 (LT), and 0.30M Reserve Block 199, Plan 51M-1257, City of Barrie, County of Simcoe being all of PIN: 58727-2129 (LT), as public highway, and to respectively name the highways Suzuki Street, Yorkshire Drive, and Greer Street.

WHEREAS Section 10 of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended (the "Municipal Act, 2001"), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, *inter alia*, public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act, 2001 or any other Act;

AND WHEREAS the Council of The Corporation of the City of Barrie deems it expedient to confirm its jurisdiction and to establish the following lands for the purposes of a public highway:

- a. 0.30M Reserve Block 196, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2126 (LT), part of Suzuki Street;
- b. 0.30M Reserve Block 197, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2127 (LT), part of Yorkshire Street;
- c. 0.30M Reserve Block 198, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2128 (LT), part of Greer Street;
- d. 0.30M Reserve Block 199, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2129 (LT), part of Suzuki Street.

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts the following:

1. **THAT:**

- a. 0.30M Reserve Block 196, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2126 (LT), part of Suzuki Street;
- b. 0.30M Reserve Block 197, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2127 (LT), part of Yorkshire Street;
- c. 0.30M Reserve Block 198, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2128 (LT), part of Greer Street;
- d. 0.30M Reserve Block 199, Plan 51M-1257, City of Barrie, County of Simcoe being All of PIN: 58727-2129 (LT), part of Suzuki Street.

are hereby each established as public highway, to be named as set out above, and that such name be affixed at the corners of each highway.

2. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.
