

COMMITTEE OF ADJUSTMENT PROVISIONAL DECISION WITH REASONS SUBMISSION NO. A27/25

IN THE MATTER OF the Planning Act, R.S.O. 1990, c.P.13, as amended, and of Zoning By-law No. 2009-141, of the City of Barrie, Section 3.0.

AND IN THE MATTER OF the premises legally described as LOTS 1 TO 5 AND PART LOTS 25 AND 31 TO 34 AND PART BARRIE VIEW DRIVE PLAN 51M446 and known municipally as **37 Mapleview Drive West** in the City of Barrie.

AND IN THE MATTER OF AN APPLICATION by Xtreme Bowling Entertainment c/o Pat Haggerty on behalf of 400-Barrie Power Centres I Inc. & 400-Barrie Power Centres Inc. c/o Allan Scully for relief from the provisions of Zoning By-law No. 2009-141, under Section 45 of the Planning Act, R.S.O. 1990, c. P.13, so as to facilitate the operation of more than three (3) amusement devices as ancillary to a recreational establishment use in the building.

The applicant sought the following minor variance(s):

1. To permit more than three (3) amusement devices accessory to a recreational establishment use, whereas the Zoning By-law under section 3.0 restricts the number of amusement devices to a maximum of two (2).

DECISION: That the variance(s) noted above be **GRANTED** (with the following conditions):

1. That the area of the building/unit occupied by amusement devices shall be accessory and subordinate to a recreational establishment use. In this regard, the floor area devoted to amusement devices shall not exceed that occupied by a recreational establishment use within the building/unit.

No written or oral submissions were received regarding this application for Committee's consideration.

REASONS:

- 1. The intent and purpose of the Official Plan is maintained.
- 2. The intent and purpose of the Zoning By-law is maintained.
- 3. The variance(s) are desirable for the appropriate development of the lands.
- 4. The variance(s) is/are minor.

Appealing to The Ontario Land Tribunal

The Planning Act, R.S.O. 1990, as amended, Section 45(12)

The applicant, the Minister or a specified person or public body that has an interest in the matter may within 20 days of the making of the decision appeal to the Tribunal against the decision of the committee by filing a notice of appeal with the City Clerk either via the Ontario Land Tribunal e-file service (first-time users will need to register for a My Ontario Account) at https://olt.gov.on.ca/e-file-service/ by selecting [City of Barrie] as the Approval Authority or by mail [City of Barrie, Committee of Adjustment, P.O. Box 400, 70 Collier Street, Barrie, Ontario L4M 4T5], no later than 4:30 p.m. on or before July 14, 2025. The filing of an appeal after 4:30 p.m., in person or electronically, will be deemed to have been received the next business day. The appeal fee of \$1,100 can be paid online through e-file or by certified cheque/money order to the Minister of Finance, Province of Ontario. If you wish to appeal to the Ontario Land Tribunal (OLT) or request a fee reduction for an appeal, forms are available from the OLT website at www.olt.gov.on.ca. If the e-file portal is down, you can submit your appeal to <u>OLT.submissions@barrie.ca</u>.

Note: In accordance with Section 45(12) of the *Planning Act* third party appeals by persons or individuals are not permitted. When no appeal is lodged within twenty days after the giving of notice, the decision becomes final and binding and notice to that effect will be issued by the Secretary-Treasurer.
