**BY-LAW NUMBER 2013-**

**A By-law of The Corporation of the City of Barrie to further amend By-law 80-138, as amended, being a By-law to regulate traffic on highways.**

**WHEREAS** Section 8 of the Municipal Act, 2001, S.O. 2001, c.25, ("the Municipal Act, 2001") provides that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

**AND WHEREAS** Section 9 of the Municipal Act, 2001, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

**AND WHEREAS** Section 10 of the Municipal Act, 2001, provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public, *inter alia* highways;

**AND WHEREAS** by resolution 12-A-180 it is deemed expedient that the Council of The Corporation of the City of Barrie to further amend By-law 80-138 as amended, being a by-law to regulate traffic on highways;

**NOW THEREFORE** the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** By-law 80-138, "**Schedule "A" – NO PARKING ANYTIME**" be amended by deleting the following in alphabetical order:

**COLUMN 1**

**COLUMN 2**

**"Berczy Street**

**West Side from Poyntz Street to Worsley Street**

**Berczy Street**

**West Side from Codrington Street to Poyntz Street**

2. **THAT** By-law 80-138, "**Schedule "A" – NO PARKING ANYTIME**" be amended by adding the following in alphabetical order:

**COLUMN 1**

**COLUMN 2**

**"Berczy Street**

**West Side from Codrington Street to Collier Street**

3. **THAT** By-law 80-138, "**Schedule "C" - RESTRICTED PARKING BETWEEN THE HOURS AS SPECIFIED MONDAYS, TUESDAYS, WEDNESDAYS, THURSDAYS, FRIDAYS FOR A LIMITED TIME DURING STATED HOURS**" be amended by deleting the following:

**COLUMN 1**

**COLUMN 2**

**COLUMN 3**

**"Berczy Street**

**Both Sides from Dunlop Street East to Worsley Street**

**Two (2) hours from 9:00 a.m. to 6:00 p.m. Monday to Friday excluding Statutory holidays".**

4. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 14th day of January, 2013.

**READ** a third time and finally passed this 14<sup>th</sup> day of January, 2013.
