The purpose of the Memorandum is to inform members of Council that in compliance with Council Motion 09-G-391 (Appendix "A") the Engineering Conditions and Drawings associated with the 970 Mapleview Drive Phase 2 subdivision are substantially finalized. The 970 Mapleview Drive subdivision is located on the north side of Mapleview Drive East, east of Yonge Street – See Appendix "B".

Approval of the Engineering Conditions and Drawings will clear the way for registration of the Plan of Subdivision (subject to certain financial and legal conditions) and for the initiation of full construction, anticipated to start in 2021.

The applicant had previously entered into a Pre-Servicing Agreement with the City (complete with financial and legal conditions) allowing for the installation of municipal sewer and water infrastructure in advance of the registration of the Subdivision Agreement.
