After many months of advocacy as well as the development of an appropriate plan through Marshall Greens report, Barrie is finally on a positive trajectory.

The one piece that remains a concern is the proposed 2 acres being cut to support overflow parking for events such as Kempenfest. A 2 acre swath is excessive and would essentially creep into the existing meadows which would hinder existing species and vegetation.
