

Bill No. 103

BY-LAW NUMBER 2015-

A By-law of The Corporation of the City of Barrie to permanently close the soil and freehold described as Part of the Road Allowance between Lots 5 and 6, Concession 13, designated as Parts 1, 2, 3 and 4, Plan 51R-40168, City of Barrie, being part of PIN 58914-0009 (LT).

WHEREAS Section 9 of the *Municipal Act*, 2001, S.O. 2001, c. 25 (the "Act"), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the *Act*;

AND WHEREAS pursuant to Section 34 of the *Act*, the council of every municipality may pass bylaws to sell the soil and freehold of part of a permanently closed highway, and to set the sale price of the land to be sold;

AND WHEREAS Part of the Road Allowance between Lots 5 and 6, Concession 13, designated as Parts 1, 2, 3 and 4, Plan 51R-40168, City of Barrie, being part of PIN 58914-0009 (LT) is no longer required for highway purposes;

AND WHEREAS the Council of The Corporation of the City of Barrie adopted motion 14-G-208.

NOW THEREFORE the Council of The Corporation of the City of Barrie enacts the following:

- THAT Part of the Road Allowance between Lots 5 and 6, Concession 13, designated as Parts 1, 2, 3 and 4, Plan 51R-40168, City of Barrie, being part of PIN 58914-0009 (LT), be and hereby is permanently closed.
- 2. **THAT** the City Clerk be authorized to execute all documents necessary to carry out the intent of this by-law.
- 3. THAT this by-law will have effect upon registration in the Land Registry Office of Simcoe County.
- 4. **THAT** Schedule "A" to this By-law, being an Affidavit of Carly Girard, sworn October 13, 2015 forms a part of this by-law.

READ a first and second time this 26th day of October, 2015.

READ a third time and finally passed this 26th day of October, 2015.
