The purpose of this Memorandum is to inform members of council that in compliance with General Committee Motion 09-G-391 (Appendix "A"), the Engineering Conditions and Drawings associated with the Hewitt's Gate subdivision (Phase 2 Registration – Blocks 3 & 7) have been finalized. The Hewitt's Gate subdivision is located south of Mapleview Drive East and east of Yonge Street. See Appendix "B".

Approval of the Engineering Conditions and Drawings will clear the way for registration of the Plan of Subdivision (subject to certain financial and legal conditions) and for the initiation of full construction.

The applicant has previously entered into a Pre-Servicing Agreement with the City (complete with financial and legal conditions), allowing for the installation of municipal services and roadworks to base asphalt in advance of the registration of the Subdivision Agreement.
