Mayor Lehman welcomed Takako Ito, Consul-General of Japan in Toronto to the City of Barrie. He provided an overview on Mrs. Ito's education and career accomplishments from 1985 to present.

Mayor Lehman invited Mrs. Ito to approach the podium to award the "Order of the Rising Sun, Gold and Silver Rays" to Mr. Morrison, former Alderman and Chair of the International Relations Committee on behalf of the Japanese Government. She noted that the Order is awarded to those individuals who have made distinguished achievements in international relations and promotion of Japanese culture.

Mrs. Ito provided a presentation concerning the bilateral and economic relations of Japan verses Canada, a data comparison chart between Japan and Canada, Japan's economic strengths, business opportunities to expand with Japanese companies, the Comprehensive and Progressive Agreement for the Trans-Pacific Partnership (CPTPP), the Japan External Trade Organization (JETRO), exciting events coming to Tokyo in 2020, the Japan Exchange and Teaching Programme (JET Programme), and the Sister-City Relations between Japan and other Ontario municipalities.

Mayor Lehman thanked Mrs. Ito for her presentation and invited Mr. Morrison to say a few words.

Mr. Morrison expressed his appreciation, privilege and noted that he is humbled to receive such an honour from the Government of Japan. He commented that it takes a community to build a partnership. He noted that the reality is that the City of Barrie, the International Relations Committee and the volunteers for over 25 years have made the delegations to international destinations a reality. Mr. Morrison advised of a youth delegation taking place this summer to Murayama, Japan and that selection of the youth group will be moving forward shortly.

Mr. Morrison concluded by thanking Mrs. Ito and Mayor Lehman for sharing this honour with the City of Barrie.

- 2. That the following Special Provisions (SP) be referenced in implementing Zoning By-law 2009-141 for the subject lands:
 - Permit a minimum lot frontage of 4.5 metres for back-to-back townhouse units, whereas 5.5 metres would be required;
 - b) Permit a maximum of ten (10) contiguous units in a row, whereas a maximum of eight (8) contiguous units in a row are permitted;
 - c) Permit a maximum 3 metres wide garage door (67% of the lot width); whereas a maximum width of 2.7 metres (60% of the lot width) would be permitted;
 - d) Permit a maximum driveway width of 3 metres, whereas a maximum driveway width of 4 metres could be permitted; and
 - e) The street townhouse dwellings within the RM3 zone shall comply with the R5 standards for street townhouse units.

- 3. That the written and oral submissions received relating to this application, have been, on balance, taken into consideration as part of the deliberations and final decision related to the approval of the application, and as identified within Staff Report PLN001-20.
- 4. That pursuant to Section 34(17) of the *Planning Act*, no further public notification is required prior to the passing of the by-law. (PLN001-20) (D14-1675)

- 3. That for a three (3) month period immediately following the expiration of the appeal period for the Official Plan Amendment and Zoning By-law Amendment, the registration fee for a second suite be waived.
