



BY-LAW NUMBER 2015-

A By-law of The Corporation of the City of Barrie to provide for advance voting and to provide for reduced hours of voting in institutions and retirement homes on Voting Day in the Ward Seven By-election.

WHEREAS, Section 43 (1) of the *Municipal Elections Act, 1996*, S.O. 1996 provides that a municipal council shall pass a by-law establishing one or more dates for an advance vote, and the hours during which voting places shall be open on that date or dates;

AND WHEREAS, Section 46(3) of the Act provides that a municipal council may pass a by-law with respect to reduced voting hours in voting places in retirement homes or those institutions as defined in Section 45(7) of the said Act, where the voting place is only for the use of the residents;

AND WHEREAS, the Council of The Corporation of the City of Barrie adopted motion 15-G-231 which provides for advance voting and reduced hours of voting in institutions and retirement homes on Voting Day in the Ward Seven By-election;

NOW THEREFORE, the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** advance/alternative voting shall be held on the dates and hours specified in Schedule "A" attached hereto, with respect to the Ward Seven By-election to be held on Monday, February 1, 2016.
2. **THAT** reduced hours of voting in institutions and retirement homes shall be held on Voting Day, with respect to the Ward Seven By-election, Monday, February 1, 2016, as specified in Schedule "B" attached hereto.
3. **THAT** this by-law shall come into force and effect immediately upon the final passing thereof.

READ a first and second time this 23rd day of November, 2015.

READ a third time and finally passed this 23rd day of November, 2015.
