SECTION "A"

Councillor Prowse advised the public that the purpose of the meeting was to conduct an appeal hearing pursuant to Barrie By-law 2006 265 (Transportation Industry) in response to the appeal submitted by Mr. S. Choudary. Councillor M. Prowse confirmed with the Deputy City Clerk that notification was conducted in accordance with By-law 2006 265 for the hearing.

Mr. Feeney cross-examined Ms. Bano with respect to the evidence that had been provided.

Members of the Committee requested clarification of the evidence provided Ms. Bano and City staff. Ms. Bano, Ms. Banting, Mr. Keene and Mr. Shaw responded to the questions.

Mr. Feeney provided closing statements on behalf of the Issuer of Licences.

Ms. Bano provided closing statements on behalf of the Applicant.
