**TAKE NOTICE** that an application has been received from **MHBC Planning c/o Kory Chisholm on behalf of YMCA of Simcoe Muskoka c/o Karen Pulla** for a minor variance from Zoning By-law 2009-141, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

**IN THE MATTER OF** the premises described as CON 12 PT LOTS 8 AND 9 RP51R31901 PARTS 29 32 TO 38 and known municipally as **535 Bayview Drive** in the City of Barrie.

This property is zoned Major Institutional (I-M).

This application, if granted by the Committee of Adjustment, will serve to permit the construction of a YMCA facility with deficient side yard setbacks.

The applicant is seeking the following minor variance(s):

- 1. A (north) side yard setback of 6.30 metres, whereas the Comprehensive Zoning By-Law, under Section 8.3.1 Table 8.3, requires a minimum side yard setback of 9 metres.**
- 2. A (south) side yard setback of 7.00 metres, whereas the Comprehensive Zoning By-Law, under Section 8.3.1 Table 8.3, requires a minimum side yard setback of 9 metres.**

**TAKE FURTHER NOTICE** that the Committee of Adjustment public hearing has been scheduled for **Tuesday, June 25, 2024**. This public meeting will be held in a virtual forum with electronic participation. The application and others will be heard commencing at **5:00 p.m. via ZOOM**.

Notices are sent to all property owners shown on the last assessment records within 60m of the subject property.

Although this is a public hearing, you are not required to attend unless you wish to speak to the application. If you have specific comments regarding this application, you may submit comments to the Secretary-Treasurer of the Committee of Adjustment at [cofa@barrie.ca](mailto:cofa@barrie.ca).

Every attempt should be made to file your submission six days prior to the Public Hearing date. Notice of the decision will be provided to each person who appeared in person or by authorized representative at the hearing and who files with the Secretary-Treasurer a written request for notice of the decision. If you do not attend, the hearing will proceed in your absence, and you will receive no further notice. You must register and attend the hearing to receive further notice.

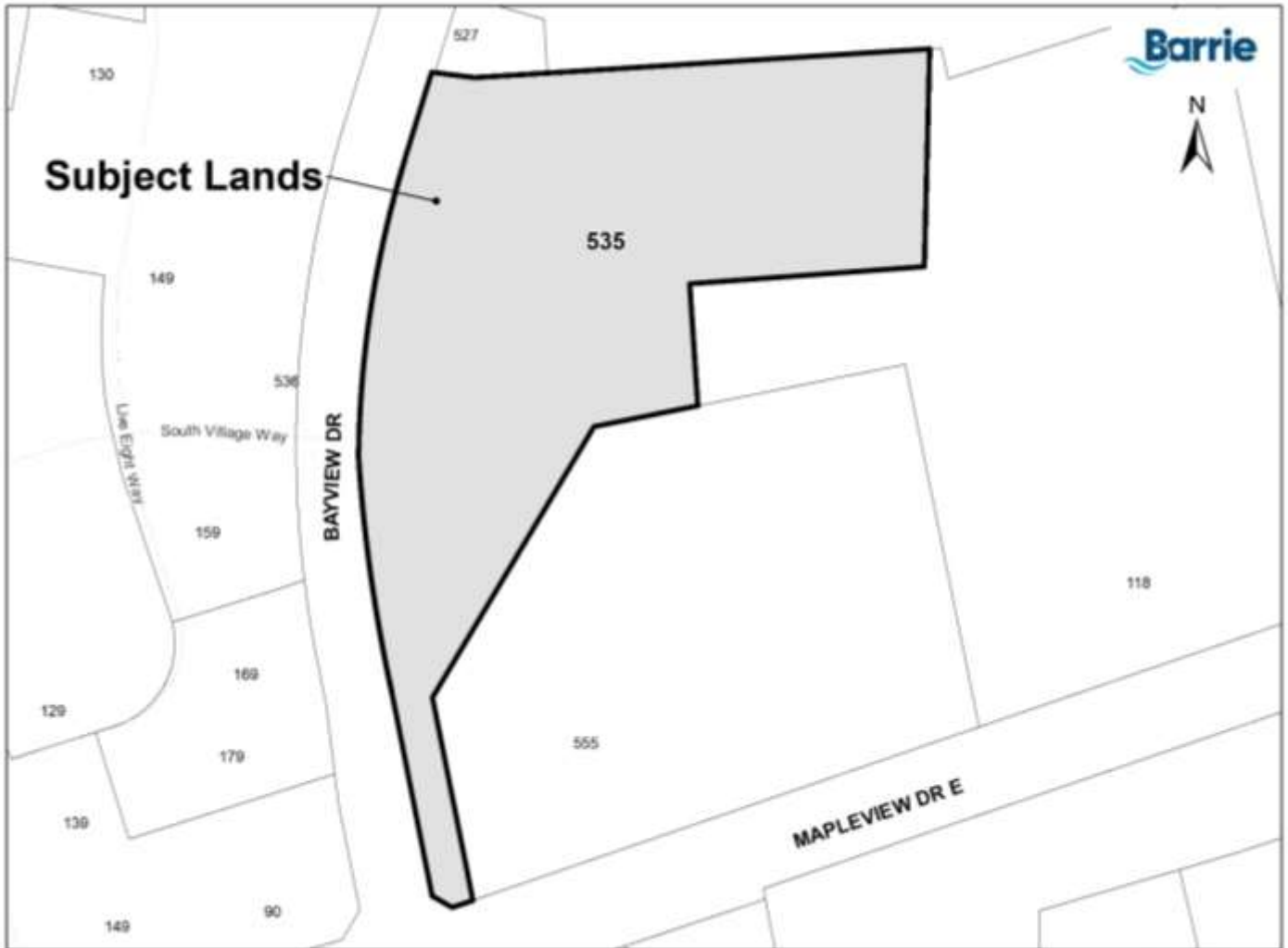

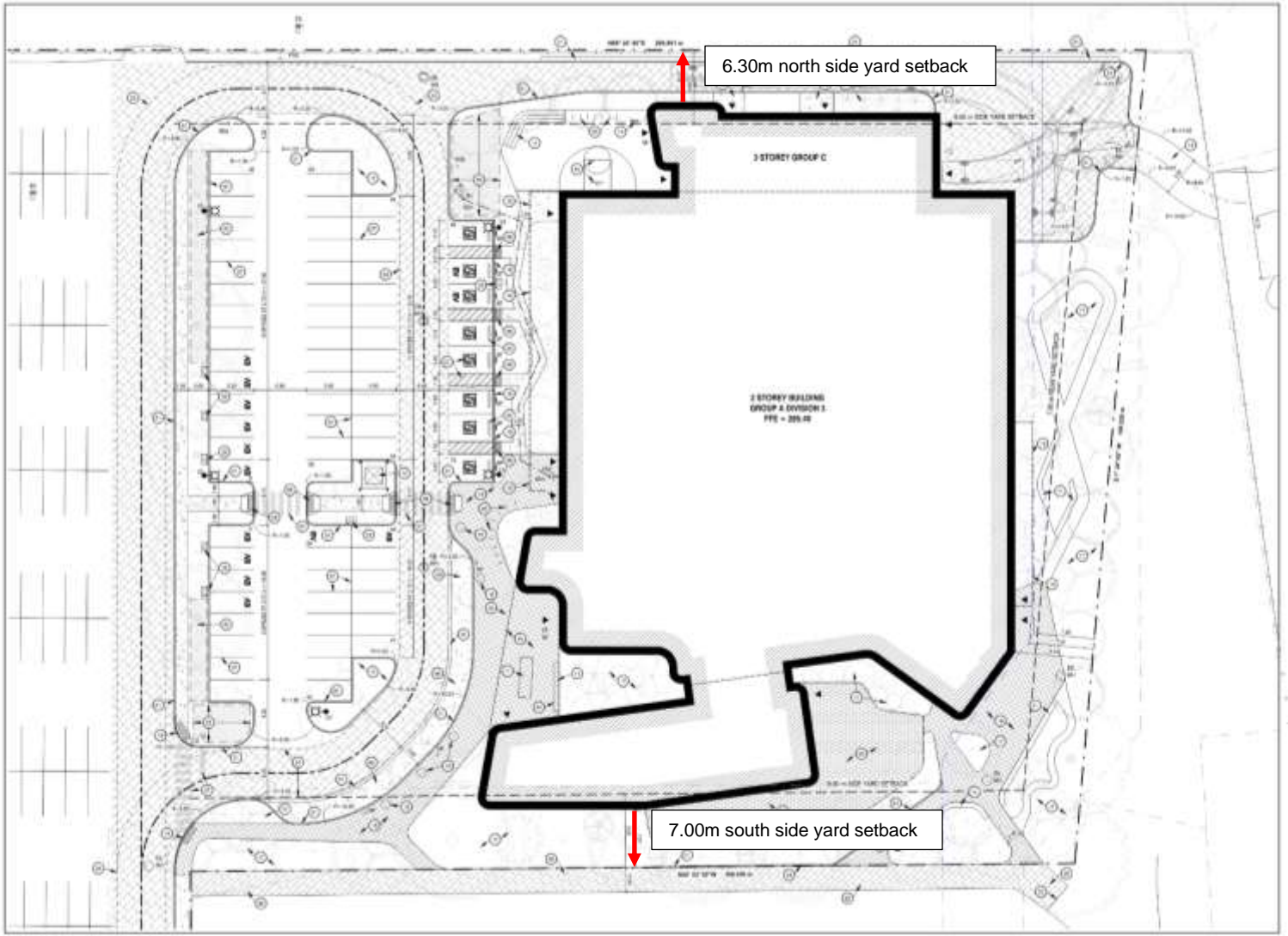
**KEY MAP**
