#### **GENERAL COMMITTEE REPORT**

**For consideration by the Council  
of the City of Barrie on October 22, 2012**

**The meeting was called to order by Mayor Lehman at 7:01 p.m. The following were in attendance for the meeting:**

**The General Committee met for the purpose of a public meeting and reports as follows:**

**Mayor Lehman advised the public that any concerns or appeals dealing with the application for the approval of a a plan of subdivision should be directed to the City Clerk's Office. Mayor Lehman confirmed with the Deputy City Clerk that notification was conducted in accordance with the Planning Act.**

**Councillor Prowse joined the meeting at 7:03 p.m.**

**SECTION "A"**

**12-G-258 APPLICATION FOR THE APPROVAL OF A PLAN OF SUBDIVISION - SMARTCENTRES BARRIE-BRYNE DEVELOPMENTS LIMITED LOCATED SOUTH OF HARVIE ROAD AND EAST OF VETERAN'S DRIVE (WARD 7) (OCTOBER 15, 2012) (File:D12-1401)**

Todd Pierce, Land Development Manager for SmartCentres (Barrie-Bryne Development Inc) explained that the purpose of the public meeting is to review the application for approval of a proposed Plan of Subdivision submitted by SmartCentres for lands located south of Harvie Road, east of Veteran's Drive. The property is legally described as part of Part Lot 7, Concession 12, City of Barrie and is located within the 400 West Planning Area and the entire land holding is 35.54 hectares in size. Mr. Pierce commented that only 13.57 hectares of the property is the subject of the application.

Mr. Pierce explained that the proposed Plan of Subdivision is for 13 industrial lots, and includes a road extension to Bryne Drive and a setback from Lovers Creek. He stated that the lands are designated General Industrial in the City's Official Plan and are zoned General Employment (EM3) in accordance with Zoning By-law 2009-141. Mr. Pierce indicated that an Environmental Impact Study (EIS) was completed to identify the existing natural heritage features and address the interaction between the proposed development and existing conditions. He reviewed the conclusions of the EIS. Mr. Pierce explained that a Traffic Impact Study (TIS) was completed to address the traffic impacts from the proposed industrial subdivision on the surrounding road network and described the findings. He concluded by providing a summary of the proposal and his opinion with respect to the rationale associated with the application.

**PUBLIC COMMENTS:**

- 1. Gary Bell of Skelton Brumwell and Associates on behalf of Bell Media** commented that he supports the application. He commented that he feels the development of the plan will allow for the extension to Bryne Drive. Mr. Bell stated that he believes there must be equitable cost sharing of the traffic infrastructure and improvements necessary for the development of lands in the Harvie, Big Bay Point Road and Highway 400 crossing area.

2. **Steve Bishop North American (Park Place)Corporation**, commented that North American (Park Place) Corporation has recently invested millions of dollars in the City of Barrie's road infrastructure. He noted that North American has a great interest in addressing Barrie's future traffic plans. He indicated that North American Park Place would like to be notified of all reports, meetings and decisions with respect to SmartCentre's application.
3. **Eric VandenHeuvel, 11 Brookwood Dr.** commented that the subject area is currently being utilized for hiking and biking. He expressed concern about the potential for increased in traffic the neighbourhood due to the development proposal and the potential for increased noise and garbage. Mr. VandenHeuvel inquired if there will be a requirement for additional power for the proposed subdivision and if this will impact the existing power lines and the health and welfare of the surrounding residents. He concluded by inquiring if the animal wildlife was included in the Environmental Impact Study.

Mayor Lehman asked a question to the presenter and received a response.

4. **Steve Miller, 31 Thrushwood Drive** inquired about the 15 metre parcel of land adjacent to the subject area and if the existing capacity on the lines would need to be increased to facilitate the proposed use. He asked if the City owns the 15 metre land area and if the proposed plan of subdivision maintains the buffer area. Mr. Miller provided comments concerning the natural berm created on the south end of the property and inquired if acoustical fencing will be installed by the developer. He asked the City to consider the request for acoustical fencing when reviewing the application. Mr. Miller commented that he believed the fencing around the residential area was downgraded and sought re-assurance from SmartCentres that acoustical fencing will be installed as part of the development. Mr. Miller inquired if he could obtain a summary of the proposed businesses intended for the plan of subdivision. He requested that SmartCentres be sensitive to the residents' concerns and issues.

The presenter provided comments concerning the buffer area.

Mayor Lehman asked a question to the presenter and City staff and received responses.

5. **Lisa Middendorf, 72 Megan Crescent** inquired about the set back requirements are along Lovers Creek area on the subject property.

City staff responded to the inquiry.

6. **Jackie Melville, 2 Ramblewood Drive** expressed concern regarding the impact the proposed development may have on the environment including the wildlife in the area. She stated that she is concerned that the development will drive the wildlife away and may force them towards Highway 400 causing accidents along the highway. Ms. Melville inquired if the developer intends to re-locate the wildlife. She expressed concern for the safety of the children and seniors living in the surrounding neighbourhood due to the construction traffic. She suggested that access onto Thrushwood Drive from the subject property be prohibited. Ms. Melville expressed concern about the amount of traffic on Maplevue Drive if Bryne Drive has not been extended. Ms. Melville expressed concern about the amount of noise pre and post development. She inquired if a sound wall could be built to replace the current fence along Thrushwood prior to the start of any construction to reduce the noise for the residential area. Ms. Melville asked if the parcel of land adjacent to Thrushwood is owned by the City and if it is designated as park land. She noted that she felt that access to the hydro lines was necessary and commented that she hopes the City retains the property.

Mayor Lehman asked a question to the presenter and received a response.

7. **Shawn Hilditch, 1 Blueberry Lane** inquired if SmartCentres owns the property beside the subject property. He asked what the timeline was for the extension for Bryne Drive and the status of the related environmental assessment.

The presenter responded to the inquiry.

8. **William James Archer, 9 Brookwood Drive** commented that he has similar concerns to Eric VandenHeuvel who spoke earlier in the Public Meeting.

9. **Cheryl Hoover, 7 Brookwood Drive** expressed her concern about the potential uses permitted with the EM3 zone, specifically manufacturing as a permitted use under the zoning. She asked what the process was if someone objected to the currently permitted uses associated with the zoning of the property.

City staff and the Mayor responded to the inquiry and explained a re-zoning process.

10. **Greg Gemmell, 144 Thrushwood Drive** commented that he would prefer to have acoustical fencing installed along lots A - G at the Plan of Subdivision phase of development rather than at the Site Plan phase as construction is anticipated to occur over a number of years.

Members of General Committee asked a number of questions concerning the presentation and received responses from City staff and the presenter.
