BY-LAW NUMBER 2011-

A By-law of The Corporation of the City of Barrie to further amend By-law 80-138, as amended, being a By-law to regulate traffic on highways.

WHEREAS Section 8 of the Municipal Act, 2001, S.O. 2001, c.25, ("the Municipal Act, 2001") provides that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS Section 9 of the Municipal Act, 2001, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act;

AND WHEREAS Section 10 of the Municipal Act, 2001, provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public, *inter alia* highways;

AND WHEREAS by motion 11-G-208 it is deemed expedient that the Council of The Corporation of the City of Barrie amend By-law 80-138 as amended, being a by-law to regulate traffic on highways;

NOW THEREFORE the Council of The Corporation of the City of Barrie hereby enacts as follows:

1. **THAT** By-law 80-138, "**Schedule "E" – Taxicab Stands**" be amended by deleting the following in alphabetical order:

| "North side Dunlop Street East | Between Mulcaster Street and Owen Street | 12:00 a.m. to 4:00 a.m. Seven (7) days a week |
| North side Dunlop Street East | Five (5) parking stalls east of Clapperton Street | 12:00 a.m. to 4:00 a.m. Seven (7) days a week |
| North side Dunlop Street West | Four (4) stalls west of Maple Avenue | 12:00 a.m. to 4:00 a.m. Seven (7) days a week". |

2. **THAT** By-law 80-138, "**Schedule "E" – Taxicab Stands**" be amended by adding the following in alphabetical order:

| <u>COLUMN 1</u> | <u>COLUMN 2</u> | <u>COLUMN 3</u> |
|-------------------------------|--|--|
| <u>Street/Location</u> | <u>Meter Number</u> | <u>Time and Use</u> |
| "West Side Bayfield Street | Nine (9) stalls south of Ross Street | 11:00 p.m. to 4:00 a.m. Seven (7) days a week |
| North side Dunlop Street East | Between Mulcaster Street and Mary Street | 12:00 a.m. to 4:00 a.m. Seven (7) days a week". |

3. **THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

READ a first and second time this 27th day of June, 2011.

READ a third time and finally passed this 27th day of June, 2011.
