**BY-LAW NUMBER 2023 -**

**A By-law of The Corporation of the City of Barrie to establish 0.30M Reserve Block 256, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4166(LT), 0.30M Reserve Block 257, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4167(LT), 0.30M Reserve Block 258, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4168(LT), and 0.30M Reserve Block 259, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4169(LT), as public highway, and to respectively name the highways Durham Avenue, Ludlow Drive, Terry Fox Drive and Lincoln Drive.**

**WHEREAS** Section 10 of the *Municipal Act*, 2001, S.O. 2001, c. 25 as amended (the "Municipal Act, 2001"), provides that a single-tier municipality may pass by-laws respecting matters set out therein including, *inter alia*, public assets of the municipality acquired for the purpose of exercising its authority under the Municipal Act, 2001 or any other Act;

**AND WHEREAS** the Council of The Corporation of the City of Barrie deems it expedient to confirm its jurisdiction and to establish the following lands for the purposes of a public highway:

- a) 0.30M Reserve Block 256, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4166(LT), part of Durham Avenue
- b) 0.30M Reserve Block 257, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4167(LT), part of Ludlow Drive;
- c) 0.30M Reserve Block 258, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4168(LT), part of Terry Fox Drive
- d) 0.30M Reserve Block 259, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4169(LT), part of Lincoln Drive

**NOW THEREFORE** the Council of The Corporation of the City of Barrie enacts the following:

**1. THAT:**

- a) 0.30M Reserve Block 256, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4166(LT), part of Durham Avenue
- b) 0.30M Reserve Block 257, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4167(LT), part of Ludlow Drive;
- c) 0.30M Reserve Block 258, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4168(LT), part of Terry Fox Drive
- d) 0.30M Reserve Block 259, Plan 51M1149, City of Barrie, County of Simcoe being all of PIN: 58091-4169(LT), part of Lincoln Drive

are hereby each established as public highway, to be named as set out above, and that such name be affixed at the corners of each highway.

**2. THAT** this By-law shall come into force and effect immediately upon the final passing thereof.

**READ** a first and second time this 15<sup>th</sup> day of February, 2023.

**READ** a third time and finally passed this 15<sup>th</sup> day of February, 2023.
