25-A-012 ADOPTION OF THE MINUTES OF THE CITY COUNCIL MEETING DATED JANUARY 15, 2025

The Minutes of the City Council meeting dated January 15, 2025, were adopted as printed and circulated.

AWARDS AND RECOGNITIONS

25-A-013 RECOGNITION OF THE MAPLE RIDGE SECONDARY SCHOOL SENIOR GIRLS BASKETBALL TEAM ON WINNING THE 2024 OFSAA GIRL'S AAA BASKETBALL CHAMPIONSHIP.

Mayor, A. Nuttall congratulated the Maple Ridge Secondary School Senior Girls Basketball Team on their successful season and on winning the 2024 OFSAA Girl's Basketball Championship.

Connor Laronde, Coach for the Maple Ridge Secondary School Senior Girls Basketball Team spoke about the integrity, character, and hard work of the players, coaches, and families.

Mayor Nuttall presented certificates on behalf of the City of Barrie to the Maple Ridge Senior Girls Basketball Team.

DEPUTATION(S) ON COMMITTEE REPORTS

Pursuant to Section 4 (16) of Procedural By law 2019-100, City Council considered the requests by Daisy Oliveros and Ash Pineau to provide emergency deputations concerning motions 25-G-015 regarding the 2025 Business Plan and Budget Service Partners.

Upon a vote of City Council being taken, Daisy Oliveros and Ash Pineau were permitted to address City Council.

25-A-014 DEPUTATIONS CONCERNING MOTION 25-G-015, 2025 BUSINESS PLAN AND BUDGET - SERVICE PARTNERS BY THE FOLLOWING INDIVIDUALS:

1. Michael Speers outlined his concerns about the Barrie Police Service budget including that policing is a more discriminatory and violent method of control, and that that further investments in policing would be a detriment to the community. Mr. Speers advised that he felt that evidence indicates that higher police budgets do not necessarily lead to a safer community and outlined the reasons for his opinion; as follows:

- over policing harms communities and can impact marginalized neighbourhoods and vulnerable populations creating a climate of fear and mistrust between law enforcement and the public.
- police are not equipped to address the root causes of crime which Mr. Speers noted he felt are items such as poverty, lack of affordable housing, mental health challenges, and inadequate access to services and employment opportunities. He felt that year after year the police budget grows but that social services, mental health programs, transit the library, and other community initiatives remain badly underfunded.
- a higher police budget diverts resources from programs that could have a greater impact on community well-being and can be directed to providing more housing, more shelter spaces, mental health supports, better transit and supervised consumption sites.

Mr. Speers outlined his thoughts advising he felt that prioritizing the police budget is choosing a reactive approach over a proactive one which includes violent encampment evictions over creating accessible shelter spaces for everyone who needs them.

Mr. Speers noted that he felt that the BPS budget should not be approved and should be reduced by 10% including a hiring freeze. He advised he felt that safety needs to be reimagined which means reallocating resources to address the root causes of crime, investing in community building initiatives and ensuring that everyone has access to the supports they need.

2. Kaitlin Baldwin spoke against the approval of the Barrie Police Service budget. She outlined incidents involving police. Ms. Baldwin shared that she felt that Barrie Police Service are being used as a catch-all to address issues in Barrie that are not their job, including housing, mental health, relational issues, and poverty.

Ms. Baldwin outlined concerns with the amount Barrie Police Service budget that is allocated to salaries and benefits and how this amount in comparison equates with social housing, shelter beds, therapy sessions and groceries for the community

Ms. Baldwin also indicated that she cares deeply about safety, autonomy of all people, health, belonging and ultimate survival. She advised that she felt that there would not be as many police calls to Busby Centre. Salvation Army or domestic cases, if shelters were fully resourced.

Ms. Baldwin shared her opinion that crime is a social issue and that police respond to crime but do not prevent it. Ms. Baldwin suggested that funds could be reinvested into social housing programs, emergency shelters, libraries, social service organizations, food banks and support for many not-for-profit organizations that provide free mental health care.

3. Daisy Oliveros expressed her desire to see at risk individuals to receive a second chance at rejoining society and to have positive interactions with police officers. She agreed that police are essential to the community when protecting vulnerable people, and that Barrie Police should be well funded resulting in the police force's ability to respond to the needs of a growing city. She addressed her concerns associated with at risk individuals' ability to access programs that will guide them in the right direction. Ms. Oliveros commented that police are human, could be stressed, tired, overworked or spread too thin which may impact them living up to the standards of excellence that is expected of them.

She addressed concerns about those who choose to exploit others and have difficulty enforcing their personal boundaries and the perception of law enforcement.

4. Ash Pineau addressed her concerns with the service provided by Barrie Police Service including, in her opinion bullying, control, greed, and manipulation. Ms. Pineau also shared her concerns with the Mayor and Council supporting the Police budget. Ms. Pineau outlined that she felt that the library is doing more the City than the police is. She advised that she felt that Council should listen to the real community of Barrie, and not provide the BPS their increase in budget, but to invest in solutions.

And Whereas Premier Doug Ford has outlined the Province of Ontario's forthcoming Fortress Am-Can Plan, which focuses on strengthening trade between Ontario and the U.S. on key issues including national security,

integrated and safe electricity grids, building out critical mineral supply chains and advanced manufacturing supply chains while bringing good jobs back home for workers on both sides of the border;

And Whereas the Federal Government has established the Canada-U.S. Relations Council to support the Federal Government as it deals with possible U.S tariffs that includes representatives from the auto sector, unions, various industries and agriculture;

And Whereas trade between Ontario and the U.S. is very important to our residents and local economies and requires all levels of government to work together in the best interest of those residents;

And Whereas according to data from the Association of Municipalities of Ontario, municipalities in Ontario are expected to spend \$250 - \$290 billion on infrastructure in the next 10 years;

And Whereas municipalities have traditionally been prevented by trade agreements from giving preference to Buy Canadian; and

Therefore, Be It Resolved That the City of Barrie call on the Prime Minister, Federal Ministers and the Federal Government's newly established Canada-U.S. Relations Council to take any and all measures to protect the interests of the Province of Ontario in any upcoming trade negotiations; and

That the City of Barrie offers its support and assistance, including formal delegations by the Mayor, CAO and/or their designates to the Federal and Provincial Governments to strike a trade deal with the U.S that will benefit all involved when it comes to strengthening our economy and keeping Ontario jobs intact; and

SECTION "D"

25-G-017 SUPPORT OF COUNTY FUNDING

Whereas the City of Barrie believes it has a responsibility to its residents to enforce its by-laws to ensure safe and accessible public spaces for the community at large;

And Whereas in paragraph 76 of the Ontario Superior Court Decision Heegsma vs Hamilton of December 23, 2024 cites "that the life and security of the applicants (the park occupants) are not put at risk by enforcement of the by-law. They are put at risk by homelessness with encampments contributing to this risk. They are lawless, dangerous and unsanitary";

And Whereas past Ontario Superior Court decisions including the Regional Municipality of Waterloo of January 27, 2023 vs Persons Unknown and City of Kingston vs Doe of November 24, 2023 have established that evicting individuals from encampments without providing adequate shelter options violates their rights under the Canadian Charter of Rights and Freedoms, consequently, the City of Barrie is unable to enforce by-laws that prohibit camping in public spaces if doing so would be unconstitutional;

And Whereas there are approximately 12 known encampments in the City of Barrie with over 100 occupants;

And Whereas in the City of Barrie there is shortage of affordable housing, social housing supports and temporary shelters beds for those living in encampments;

And Whereas the County of Simcoe has submitted a funding application to the Province of Ontario for funding under the Encampment Response Initiative to support an increase shelter capacity, restoration of public lands at key encampments and to provision of wraparound support with their partnering organizations;

And Whereas to be considered for this funding from the Ministry of Municipal Affairs and Housing a written pledge from the County was required noting that funding received would be put towards ending encampments by providing housing options for those experiencing homelessness;

And Whereas as a result of signing the pledge by Warden Clarke, the County of Simcoe is also eligible to receive top-up funding from the Canada-Ontario Housing Benefit to support transition individuals from shelter programs into longer-term housing to free up space to address immediate shelter needs of individuals in encampments; And Whereas if the County is successful in this funding application, the City of Barrie would benefit from additional shelter spaces and possible funding for restoration of public spaces

Now Therefore Be It Resolved:

- 1. That the Council of the City of Barrie endorse and support the County of Simcoe's application to the Province of Ontario for funding under the Encampment Response Initiative; and
- 2. That Mayor Nuttall on behalf of City Council send correspondence to the Ministry of Municipal Affairs and housing advising of Council's support of this important funding application.
