The Application

- Our application is seeking approval to allow the existing sign at 509
 Bayfield Street (Georgian Mall) to display third party messaging.
 The existing sign can currently display ads for any of the 130+
 tenants located inside the mall. We are seeking approval to expand
 this opportunity to other local and national businesses.
- We are not proposing any changes to the existing sign's attributes.
 The height, size, illumination and location will remain unchanged.










Property and Surrounding Area













Required Variances

The Variances required to display Third Party Messaging are:

- Being located on a developed commercial lot, and
- Being located less than 15m from a City property line

The sign will comply with all other Sign By-law requirements for Poster Panel signs, as required by Section 11 and Section 12.

The opportunity to display emergency and City-related messaging will remain intact if this approval is granted.










Side-by-Side Comparison

Staff Concerns re: Setting a Precedent

In their report, Staff commented that setting a precedent for other signs was one of their main concerns.

To confirm, approving this request will not change any of the Sign By-law provisions for Poster Panel Signs. Each application for a new Poster Panel that requires a variance will be reviewed by Staff on its own merits, and a decision would be made based on the specific details within such applications.

This Committee can rest assured that granting the approval for the existing sign to display third party copy will not lead to any expanded permissions for other Poster Panel signs.
