The Active Transportation and Sustainability Committee met and discussed the following:

### **ORIENTATION FOR COMMITTEE**

Tara McArthur Deputy City Clerk provided a presentation regarding an Orientation for the 2022 to 2026 Committee Members.

Ms. McArthur discussed slides concerning the following topics:

- The Council and Committee Member Code of Conduct;
- The Municipal Conflict of Interest Act;
- The City of Barrie Procedural By-law;
- An overview of meeting procedures:
  - o The basics of Parliamentary Law; and
  - o The role of the Chair, Committee Members and the Legislative Coordinator.
- The decision making process; and
- The reporting structure of the Active Transportation and Sustainability Committee.

Members of Committee asked a number of questions of Ms. McArthur and received responses.

### **MEETING SCHEDULE**

### **TERMS OF REFERENCE**

The Committee discussed the following items concerning the terms of reference:

- Inviting staff from Corporate Facilities to a future meeting for an update on Climate Change.

The Committee agreed to appoint Wilf Steimle as Vice-Chair of the Active Transportation and Sustainability Committee for the 2023 - 2024 term of the Committee and revisit the position of Vice-Chair for the rest of the term.

### **STATUS OF OFFICIAL PLAN**

Councillor, A.M. Kungl provided an update on the status of the City's New Official Plan. She mentioned that the Province of Ontario has provided the municipality with a list of changes for the Official Plan, which are in alignment with provincial legislation.

Councillor Kungl commented that she would update the Committee once further information on the new Official Plan becomes available.

The Committee agreed to invite staff from Development Services to a future meeting to provide an update concerning the new Official Plan.

### **PRIVATE TREE BY-LAW UPDATE**

Councillor, A.M. Kungl provided an update regarding motion 23-G-082 concerning the Private Tree By-law and Ecological Offsetting Review. She commented that the plans do not include the creation of a tree by-law subcommittee and that the current Private Tree By-law 2014-115 is still in effect.

The Committee agreed to invite staff from Development Services to a future meeting to provide an update on the Private Tree By-law.

### **2023 WORK PLAN**

There was no discussion concerning the 2023 Work Plan. Further discussion will take place at a future meeting.
