New Version: Clearly aligns with the FPPA (1997), EMCPA, and the Fire Master Plan. **Comment**: The New Version by-law better reflects modern legislative requirements, including alignment with Council-adopted plans (Fire Master Plan and Community Risk Assessment), adding legal clarity and strategic integration.

Current Version: Contains limited operational and legal definitions. Too much risk and not compliant.

New Version: Expanded to include:

- "Automatic Aid," "Community Risk Assessment," "CEMC," "NFPA," "WSIB," etc.
- Updated Fire Chief reporting structure.

Comment: These additions reflect updates to provincial regulations (e.g., O. Reg. 378/18), emergency management law (EMCPA), and best practices in fire service operations and terminology.

Current Version: Includes high-level service descriptions. Not O.Reg or NFPA/OFM compliant.

New Version: Clearly lists all mandated services: suppression, inspection, education, hazmat, medical tiered response, drone/UAS operations, emergency management, etc. **Comment**: Provides operational clarity, transparency to the public, and alignment with NFPA 1710, FPPA, and Fire Marshal expectations.

Current Version: Limited to Fire Chief and Deputy Chiefs. Not compliant with delegation/authorities. Possible legal challenge. OFM non-compliant.

New Version: Includes Assistant Deputy Chiefs, and delegation powers under FPPA Sections 14, 19, 20.

Comment: Better supports a modern command structure EMP, codifies succession, and enhances legal authority through written delegation powers.

Current Version: Covers powers under FPPA for inspections, demolitions, and barricading.

New Version: Adds Charter-compliance for dwelling entry and expands legal context. Much more resilient in the context of legal authorities.

Comment: Improved legal precision and rights-based compliance under the Canadian Charter of Rights and Freedoms. CORF - mandated.

Current Version: Emergency management roles not addressed. Non-compliant. **New Version**: Assigns BFES responsibility for municipal emergency management, EMCPA and Reg. 380/04 compliance, and CEMC designation.

Comment: Strongly modernized; ensures OFM/NFPA/EMO compliance, critical for municipal (aka City) risk management.

Current Version: Covers Simcoe Mutual Aid, dispatch agreements.

New Version: Clarifies approval authority, Council delegation, and includes mutual/automatic/tiered response and inter-agency agreements. OFM/EMO compliant now.

Comment: Strengthens inter-municipal collaboration frameworks and formalizes support operations. Forward thinking.

Current Version: Implied through reporting duties. - implied vs stated (challenge issues).

New Version: Lists records for incidents, training, inspections, WSIB, maintenance, and performance metrics.

Comment: Enhances accountability, performance measurement, and compliance with audit requirements (OFM/EMO).

Current Version: Mentions "annual report."

New Version: Mandates reporting on activities, performance indicators (KPI's), CRA integration - compliance and best practices.

Comment: Supports modern municipal performance transparency and informed Council decision-making.

Current Version: Grants Mayor and Clerk authority in consultation with Fire Chief.

New Version: Consolidates dispatch authority under Fire Chief with possible delegation. (CoC for Fire Chief)
