#### The Town and Gown Advisory Committee met and reports as follows:

## 11-TGC-009 TERMS OF REFERENCE

The Committee met and discussed the objectives for the 2010 to 2014 Town and Gown Committee Term. The finalized objectives have been included in the Terms of Reference document attached as Appendix 'A' to the report of the Town and Gown Committee meeting dated September 27, 2011.

# 11-TGC-010 SELECTION OF VICE CHAIR

The Committee selected L. L'Heureux-Desjardins, Community Member, as the Vice-Chair.

## 11-TGC-011 UPDATE CONCERNING POTENTIAL PERMIT PARKING

J. Sharp, Senior Traffic Technologist provided the Committee with a handout containing information comparing 3 hour parking limits and permit parking.

The Committee asked a number of questions concerning the information provided.

## 11-TGC-012 UPDATE CONCERNING PARKING ON 'S' CURVES

J. Sharp, Senior Traffic Technologist, discussed the hazards related to parking along 'S' Curves and provided a number of suggestions to solving this issue.

# 11-TGC-013 GENERAL UPDATES

C. Alexander, Supervisor of Property and Zoning Standards, provided the Committee with an update concerning property standards and zoning enforcement complaints. He noted that the number of property complaints in the College Area are reduced from previous years. He provided general information concerning Boarding, Lodging and Rooming (BLR's) houses and Single Family Dwelling's (SFD's). The Committee requested a presentation concerning BLR's at a future meeting.

B. Russell, Manager of Municipal Law and Prosecution Services, provided the Committee with an update regarding Municipal Law and Prosecution Services including the types of complaints and the volume of complaints received within the College Area.

B. Bowles, Barrie Police Services, provided the Committee with an update regarding Barrie Police Services and the high volume of complaints received within the College Area. R. Ridell, Barrie Police Services, suggested that Georgian College establish a Code of Conduct for students both on and off the campus.

M. Beaudoin, Associate Vice-President, Georgian College, provided the Committee with an update regarding the College strike. She explained that the College is currently investigating the feasibility of implementing a Code of Conduct and will provide an update to the Committee concerning this matter. The Committee asked a number of questions concerning the information provided.
