STUDENT MAYOR(S)

16-A-040 COMMENTS BY OUTGOING STUDENT MAYOR

Jackson noted that he underestimated the complexity of discussions and the different concerns of the residents. Wendy Cooke, Deputy City Clerk called upon Kwynne Loupelle of Monsignor Clair Catholic School to be sworn into office as Student Mayor.

After being sworn into office Kwynne assumed her seat next the Mayor Lehman. Mayor Lehman introduced the members of City Council to Kwynne. He noted that the members of City staff and representatives of the community's media were also in attendance.

Prowse declared a potential pecuniary interest concerning motion 16-G-071 of the General Committee Report dated April 4, 2016 related to a Letter concerning Laurentian University Students which was considered by City Council on April 11, 2016 in his absence. He explained that the nature of his potential pecuniary interest is related to the fact that his son is a student at Laurentian University.

Upon a vote of Council being taken, Ms. Laking was permitted to address City Council.

DEPUTATION BY BILL SCOTT REGARDING MOTION 16-G-083, OFFICIAL PLAN AMENDMENTS, ZONING BY-LAW AMENDMENTS AND DESIGN GUIDELINES TO PROTECT THE CHARACTER OF THE HISTORIC NEIGHBOURHOOD AREAS

On behalf of the Allandale Neighbourhood Association and the Historic Neighbourhood Strategy Committee Mr. Bill Scott provided a deputation in opposition to an aspect related to motion 16-G-083. Mr. Scott discussed the Historic Neigbourhood Strategy implemented in 2010 and congratulated staff on the current program and proposed design guidelines. He thanked staff for allowing the Association and Committee's input as they were delighted by the outcome. Mr. Scott commented that there is one item within the proposed Guidelines that has been difficult to address related to additions to properties within the historic neighbourhoods.

Mr. Scott discussed slides that illustrated photos of homes within the historic neighbourhood that he believes are associated with recognizing provisions that would address disproportionate additions in keeping with the character of the home and neighbourhood. He noted that he is not objecting to additions to homes. Mr. Scott also commented on slides displayed pictures of additions he feels that are not in keeping with the character of the neighbourhood and discussed his concerns related to these additions. Mr. Scott discussed the difficulty an addition should be without dominating the character of a home. He stated that he had discussed with staff the potential to lower the maximum lot area permitted for constructing an addition, but it was determined that this would not be a manageable way to address the situation.

Mr. Scott requested that City Council amend the motion to provide for staff to conduct more research to look at methods to lessen the impact of disproportionate additions within the historic neighbourhood areas.

Members of Council asked several questions of Mr. Scott and City staff and received responses.

DEPUTATION REGARDING MOTION 16-G-082, SAM CANCILLA PARK 16-A-044 **GAZEBO REHABILITATION (WARD 2)**

Ms. Kelly Lester provided a deputation in opposition to motion 16-G-082, Sam Cancilla Park Gazebo Rehabilitation. Ms. Lester reiterated discussions by General Committee concerning the types of rehabilitation that should be considered for Sam Cancilla Park and the gazebo. She noted that she is aware that the park will receive a makeover in the next five years and provided suggestions for the \$25,000 that would not be used as part of the proposed option, such as extending the asphalt path in the park to the road, or having Georgian College students paint a mural on one of the walls. Ms. Lester advised that she has seen young families use the swing sets. Ms. Lester also suggested if the park is re-graded consideration be given to a tiny stage/plateau to be used for cultural and children's events. In closing, Ms. Lester thanked Council for the opportunity to be heard.

In closing, Ms. Laking commented that if Sam's name is on the park, the gazebo needs to stay in the park.

- The G and G Jet Centre Business Aviation Facility;
- The 2015 investment by Elevated Aviation;
- The Greater Toronto Airports Authority (GTAA) Strategic Plan, the commissioning of a working group, and the potential creation of a regional airport system that could include LSRA; and
- The airports participating in the regional airport system and the criteria for being selected.

Mr. Lifshiz discussed slides concerning the following topics:

- The GTAA's Multi-Year Plan;
- The 2011 Strategic Development and Land Use Plan and 2016/17 Plan update; and
- Initiatives underway to establish the Lake Simcoe Regional Airport as a premier commercial business aviation centre.

FERNDALE DRIVE NORTH RECONSTRUCTION, TIFFIN STREET TO DUNLOP STREET - PROVISION OF SANITARY SERVICING AWARD OF CONTRACT 2016-030T (WARD 5)

- 1. That a by-law be prepared to authorize the recovery of capital costs for the installation of sanitary servicing of unserviced properties on Ferndale Drive North between Tiffin Street and Dunlop Street through the collection of a per metre frontage charge plus lateral costs for benefiting properties abutting the proposed new sections of sanitary sewer, as provided under Section 326 of the Municipal Act, with the option of payment of the sanitary charges over a 10 year period with interest.
- That additional funding in the amount of \$328,968 for the watermain component of this project as described in Appendix "A" of Staff Report ENG005-16, be approved.
- That Contract 2016-030T for Ferndale Drive North Reconstruction from Tiffin Street to Dunlop Street West be awarded to Arnott Construction Limited, in accordance with their tender dated March 15, 2016, in the amount of \$5,324,287 excluding HST. (ENG005-16) (File: T05-FER)

 That the tax ratios for the 2016 taxation year be established as follows:

a)	Residential/farm property class	1.000000
b)	New Multi-residential	1.000000
c)	Multi-residential	1.000000
d)	Commercial	1.433126
e)	Industrial	1.516328

f)	Pipelines	1.103939
g)	Farmlands	0.250000
h)	Managed forest	0.250000

- 2. That the capping program be funded by clawing back decreases from within the affected property tax classes.
- 3. That the recommended capping parameters for commercial, industrial and multi-residential properties be maintained as follows:
 - a) The property tax cap be set at an amount representing 10% of the previous year's annualized taxes;
 - b) Any property within +/- \$250 of the Current Value Assessment (CVA) taxes be moved directly to CVA taxation;
 - c) Any property that reaches the CVA level of taxation be removed from the capping program:
 - d) Exclude any property whose classification changes from capped to clawed back, or vice versa; and
 - e) A minimum cap of 5% of the previous year's CVA taxes.
- 4. New construction thresholds be maintained as follows:
 - a) Up to 70% of CVA-level taxes in 2005;
 - b) Up to 80% of CVA-level taxes in 2006;
 - c) Up to 90% of CVA-level taxes in 2007; and
 - d) Up to 100% of CVA-level taxes in 2008 and beyond.
- That the discounts for the commercial and industrial sub-classes for vacant land and excess land be maintained at 30% and 35% respectively.
- 6. That two sub-classes for Farmland Awaiting Development be maintained in each of the multi-residential, commercial and industrial property classes at the following discounts:
 - a) Phase I 25% discount off the residential tax rate; and
 - b) Phase II 0% discount off the applicable property class tax rate.

- 7. That the City of Barrie continue its existing Rebates for Charitable Organizations Program providing a tax rebate for Registered Charitable Organizations, as defined in Section 248(1) of the Income Tax Act, R.S.C. 1985, Chapter 1, at a rate of 40% of the current year's taxes applicable to the space occupied.
- 8. That the Registered Charities eligible for the tax rebate program are required to submit an annual application and provide evidence of taxes paid satisfactory to the Treasurer or his/her designate.
- 9. That the City Clerk be authorized to prepare all necessary by-laws to establish the 2016 taxation and capping policies as described in Staff Report FIN003-16. (FIN003-16) (File: F00)

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

- That staff in the Legislative and Court Services Department review the legislative reforms and, if the legislation is passed, prepare a report to General Committee related to any recommended changes for the 2018 and/or subsequent municipal elections in Barrie;
