The Active Transportation and Sustainability Advisory Committee met and reports as follows:

## **SECTION "A"**

### **PRESENTATION CONCERNING FIREBIRD COMMUNITY CYCLE**

**Nicholas Flinn declared a potential pecuniary interest on the foregoing matter as he is a volunteer member of the Firebird Community Cycle. He did not participate or vote on the matter. He remained in the Sir Robert Barrie Room.**

Geri Poisson provided a presentation concerning the Firebird Community Cycle.

Mr. Poisson discussed slides concerning the following topics:

- The mission statement of Firebird Community Cycle;
- The goals of Firebird Community Cycle as follows:
  - Active Transportation;
  - Education;
  - Provide skills and training;
  - Sustainability; and
  - Community.
- The achievements of the organization;
- An illustration depicting the current location of the organization;
- A summary of the current operational challenges;
- The current activities of the organization;
- An overview of the Barrie Landfill Bike Diversion program;
- The proposal and request of the Firebird Community Cycle;
- The Community Bike Shops from the following municipalities:
  - City of Peterborough;
  - City of Brampton;
  - City of London; and
  - City of Guelph.
- A summary of the organization.

Members of Committee asked a number of questions of Mr. Poisson and Brett Gratrix, Senior Manager of Transportation and received responses.

Mr. Gratrix suggested that Firebird Community Cycle could potentially look for support from private property owners for a viable location for their organization.

The Committee discussed the City of Barrie formalizing the Landfill Bike Diversion Pilot Program with Firebird Community Cycle, assisting the organization to seek grant funding opportunities and/or partnerships for a permanent location and the potential of creating a grant fund to support community-based cycling groups to advance active transportation.

The Active Transportation and Sustainability Advisory Committee met and recommends adoption of the following recommendation(s):

**LANDFILL BIKE DIVERSION PILOT PROGRAM**

That the Landfill Bike Diversion Pilot Program be formalized, and that Firebird Community Cycle be the recipients of the donations.

#### **REQUEST FROM MAPLE LEAFS FOREVER FOUNDATION**

Kevin Rankin, Manager of Parks and Forestry provided an overview of the Maple Leafs Forever Foundation that supports the planting of Native Canadian Maple Trees. He discussed the City's policies related to trees in the municipality.

The Committee provided its feedback to Mr. Rankin and indicated its support of the planting of Canadian native maple trees in the municipality.

The Active Transportation and Sustainability Advisory Committee met and recommends adoption of the following recommendation:

## **SECTION "D"**

### **MAPLE LEAFS FOREVER**

The City of Barrie recognizes the importance of the native maple tree, our arboreal emblem and we commit to favour planting native maples whenever a maple tree is called for in any municipal planting project.

### **BIRD FRIENDLY CITY AND UPCOMING EVENTS**

Dorothy McKeown advised that Saturday May 13, 2023 is "World Migratory Day".

Ms. McKeown acknowledged that representatives of Nature Barrie presented a certificate to Mayor Nuttall on May 10, 2023 designating the City of Barrie as a Bird Friendly City. She advised that the City of Barrie is the 15th municipality in Canada to earn the designation and has worked in collaboration with Nature Barrie and Nature Canada.
