Tammie Maynard, Legislative Coordinator provided an update concerning the Committee budget and Legacy Fund.

Mark Sachkiw Co-Chair provided an update concerning the Barrie International Partnership website.

YOUTH AMBASSADORS/GLOBAL PERSPECTIVES PROGRAM
