1. That the following proposed Municipal Street Name identified in Appendix "A" to Staff Report PLN006-19 for the Draft Plan of Subdivision located at the North East corner of Ardagh Road and Wright Drive, be approved:
 - a) Street A – Hampton Lane.

PURPOSE & BACKGROUND

Report Overview

2. The City of Barrie Planning Department approved Draft Plan of Subdivision Application D12-434 and Zoning By-law Amendment D14-1636 (By-law 2018-005) on December 4, 2017.
3. As part of this process, the subdivision requires a street name to be approved to begin the municipal addressing process.
4. Council approval of this street name will allow municipal addressing to proceed.

ANALYSIS

5. The proposed street name was circulated to external and internal departments for commenting.
6. No concerns were raised regarding Hampton Lane and therefore that street name can be used in this development.

ENVIRONMENTAL MATTERS

7. There are no environmental matters related to the recommendation.

ALTERNATIVES

8. The following alternative is available for consideration by General Committee:

Alternative #1

General Committee could reject the recommended motion and request that the applicant provide a new street name for the subdivision.

This alternative is not recommended as a street name is required to begin the municipal addressing processes and the proposed name meets all requirements of the street naming policy. Restarting the circulation process would delay the emergency addressing process significantly.

9. There are no financial implications for the Corporation resulting from the proposed recommendation.
