Key points are that the everyone talks about the lakefront as being open to all residents, for some reason organized sporting events, seem to be excluded from this opportunity, save a few events ( Triathlon, occasional high school rowing event)

Many other community groups Performing arts, cultural events, community fund raisers ( dragon boats, walk a- thons etc), festivals, passive recreational activities ( swimming, biking, playgrounds, picnics etc ) are regular activities displayed on the waterfront but not sports

Sport groups are restricted to existing playing fields , not usual public access areas but more, aligned with schools, community parks, or community Centres, which are specific to sporting facilities and sporting fields. Usually only participants of the sport and/or their parents attend these activities. Having a facility on the waterfront, exposes the non-sporting user to not only another entertainment venue that they could watch or observe while there, but also exposes "youth" activity and its benefits to the general public but also youth to an environment not exclusive to sport

Sport, like the arts and culture are strong builders of community and should be together, not competing with each other .

South end Lakefront reflects a passive area, - Military park,overflow parking, biking and hiking,... now canoeing, rowing, sea cadets, we are opening up another kilometer of the lakefront to be utilized by more of the general public.

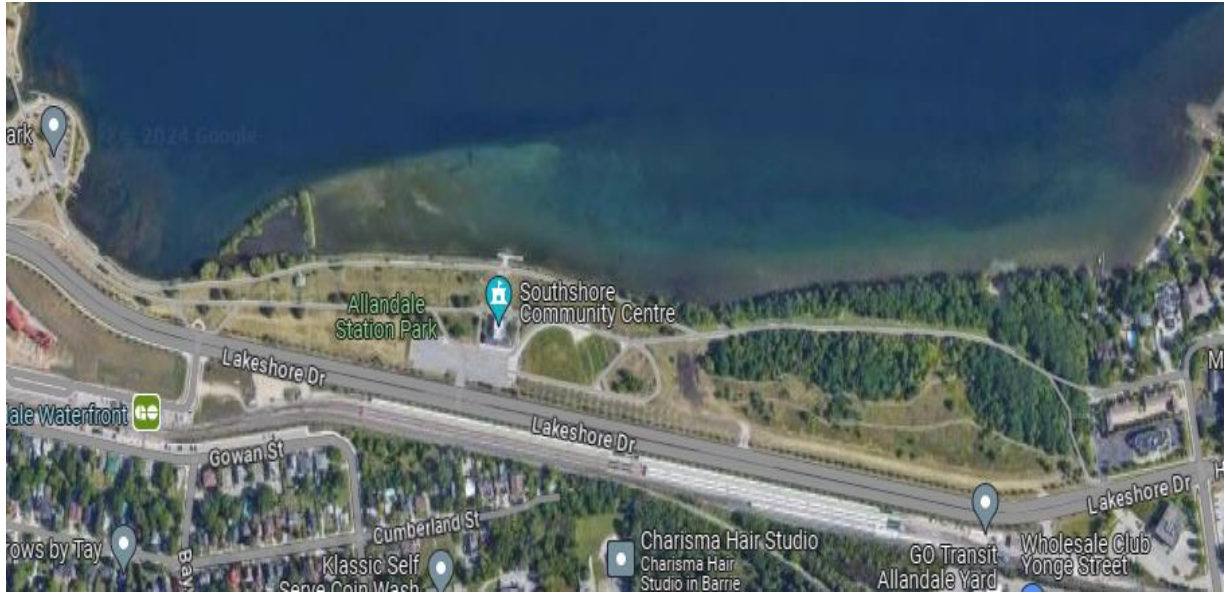

Dear Mayor Nutall and Members of Council:

The Minets Point Residents wish to voice their opposition to the proposal for the development of a multi-use sports field and parade grounds at South Shore Centre / Allandale Station Park. Our primary concern is that we believe that the South Shore/Allandale Station Park is not the correct location for a sports field.

In our deputation, we wish to share our concerns related to the proposal and ask for Council to postpone the approval of the development to hold widespread public consultation prior to any final approval of the sports field in this location. This consultation should include studies such as alternate locations for the sports field/parade grounds, traffic patterns resultant to this development, environmental implications, cataloguing of species including those at risk, health and environmental impacts of artificial turf, and noise implications.

The Barrie Waterfront Trail is used by many, accessible by all, and this plan will make a portion of this area only accessible to a select few. This is not how we understand a fully public space should function. We believe that there is a need for public sports field spaces in the City, and that the Cadet's need a safe space to meet. We are not opposed to the Sea Cadets building construction as an addition to the South Shore Centre, however we believe that a new sports field location elsewhere can be solved creatively with a little more research, consultation and time.
