**RE: MUNICIPAL STREET NAMING FOR CAMPBELL DRAFT PLAN OF SUBDIVISION (D12-427)**

The purpose of this Memorandum is to provide members of Council with an update concerning street naming for the Campbell Draft Plan of Subdivision (File: D12-427) located in Hewitt's Secondary Plan Area on lands legally described as Part Lot 6 Plan 98; Part 1 Plan 51R40932, City of Barrie.

Providing street names as part of future developments that are unique and do not conflict with existing street names in surrounding municipalities supports well planned transportation network. The street names will allow residents and Emergency Services to navigate easily to and from this future development and other areas in the City of Barrie, which fosters a safe and healthy city.

The street names for the Campbell Draft Plan of Subdivision were approved by City Council as follows:

1. **Kneeshaw Drive**; the street segment identified as Street "D" was approved as a street name by Council on May 5, 2018, as per Staff Report PLN010-18 – Appendix "B"; for a new collector road in the Hewitt's Secondary Plan Area and it extends in a North-South direction through the development as shown on Appendix "A" to this Memorandum dated September 27, 2023.
2. **Flan Boulevard**; a portion of the street segment identified as Street "E" was approved as a street name by Council on June 24, 2019, as per Staff Report PLN027-19 – Appendix "A". It is the extension of a local road that extends in a East-West direction as shown on Appendix "A" of this Memorandum dated September 27, 2023.
3. **Gouda Lane**; the street segment identified as Street "G" was approved as a street name by Council on June 24, 2019, as per Staff Report PLN027-19 – Appendix "A". It is the extension of a local road that extends in a North-South direction as shown on Appendix "A" to this Memorandum dated September 27, 2023.
4. **Shiraz Trail**; part of the street segment identified as Street "F" was approved as a street name by Council on June 24, 2019, as per Staff Report PLN027-19 – Appendix "A". It is the extension of a local road that extends in a North-South direction then East-West to connect to Street "G" as shown on Appendix "A" to this Memorandum dated September 27, 2023.
5. **Fondue Gate**; the street segment identified as part of Street "E" and part of Street "F" was approved as a street name by Council on June 24, 2019, as per Staff Report PLN027-19 – Appendix "A". It extends in a East-West direction as shown on Appendix "A" to this Memorandum dated September 27, 2023
