KEY HIGHLIGHTS

- Following a deferral from Barrie City Council in August 2019 on the decision regarding a Supervised Consumption Site (SCS) located at 90 Mulcaster Street, a new lead applicant (the Canadian Mental Health Association Simcoe County Branch (CMHA-SCB)) and coapplicant (the Simcoe Muskoka District Health Unit (SMDHU)) were identified. With the support of a SCS Site Selection Advisory Committee and a local volunteer realtor, the search was continued for an appropriate location for a SCS in Barrie.
- In September 2020, using a number of criteria, 31 Toronto Street (back building on the lot) and 110 Dunlop Street West (Unit 4, back of building) in Barrie were selected as proposed locations for an SCS by the SCS Site Selection Advisory Committee. Comprehensive community engagement was planned to understand the neighbourhood perceptions of benefits and challenges for each of these locations. The SCS Site Selection Advisory Committee decided that a key component of this process would be a community survey of those who live, work, own a business, or go to school in Barrie.
- A total of 1,200 people who live, work, own a business, or go to school in Barrie participated in the online survey between October 7, 2020 and October 30, 2020. It is important to note that the results obtained from this survey cannot be generalized to the population of Barrie, and only represent the opinions of those who chose to complete the survey.
- The majority of respondents live in Barrie (88.0%), while 62.1% work in Barrie, 16.5% own a business in Barrie, and 8.9% go to school in Barrie.
- Table 1 represents the key highlights for both 31 Toronto Street, Barrie and 110 Dunlop Street West, Barrie.

Mitigation Strategies

31 Toronto Street, Barrie (Back Building on the Lot)

Overall top three mitigation strategies:

- Evaluate the services to see what is working and what is not, share results with the local community to take action (60.2%)
- 2. Provide the local community with information about the goals of supervised consumption sites and how they can help the community (53.1%)
- 3. Increase clean-up of publicly discarded needles (52.9%)

Respondents who provided a postal code located within 250 m of the proposed locations also indicated increase security in the area (45.1%) as a top way to address their concerns.

110 Dunlop Street West, Barrie (Unit 4, Back of Building)

Overall top three mitigation strategies:

- Evaluate the services to see what is working and what is not, share results with the local community to take action (59.7%)
- 2. Provide the local community with information about the goals of supervised consumption sites and how they can help the community (56.7%)
- 3. Increase clean-up of publicly discarded needles (54.3%)

Respondents who provided a postal code located within 250 m of the proposed locations also indicated increase security in the area (53.5%) as a top way to address their concerns.

COMMUNITY SURVEY ON PROPOSED LOCATIONS FOR A SUPERVISED CONSUMPTION SITE IN WARD 2 BARRIE: SUMMARY REPORT

BACKGROUND

In 2019, the Canadian Mental Health Association Simcoe County Branch (CMHA-SCB), the Gilbert Centre, the Simcoe Muskoka District Health Unit (SMDHU), and the David Busby Centre began an application to Health Canada and to the Ontario Ministry of Health for a Supervised Consumption Site (SCS) in Barrie as part of a comprehensive strategy to address the current opioid crisis. This included several avenues for community engagement with those who live, work, or go to school in Barrie, people with lived experience of drug use, and community partners to understand general perceptions of having an SCS in Barrie.

In March 2019, a specific neighbourhood open house surrounding the proposed SCS location of 90 Mulcaster Street was conducted. The data from the neighbourhood open house and previous community consultations, as well as the recommendation to proceed with an application for the Mulcaster location, was brought to Barrie City Council in May 2019. Following a series of considerations, in August 2019 Barrie City Council deferred the motion regarding an SCS at 90 Mulcaster St and requested that the applicants undertake additional public consultation regarding specific sites under consideration. For a detailed timeline of the SCS planning to date, see SCS planning Timeline.

Following this decision by Council, a Barrie SCS Site Selection Advisory Committee was created to ensure this work was informed by a range of stakeholder perspectives going forward. Applicants in this process were identified as CMHA-SCB and SMDHU, with CMHA-SCB being the lead applicant and operational lead, and SMDHU as co-applicant and taking the lead on consultations. The intention of the committee was to provide a forum for open communication and exchange of information, discussion of potential site options and approaches to community engagement, and fulfill its purpose by being solution-focused and responsive to the needs of people who use drugs and the surrounding community. The Committee had been active since Sept 2019, with the exception of a brief pause in the early stages of the global pandemic between April and June 2020, and has now determined a short list of potential SCS locations. Comprehensive community engagement is required to understand the neighbourhood perceptions of benefits and challenges of each of these site locations. The SCS Site Selection Advisory Committee decided that a key component to this engagement process would be a community survey of those who live, work, own a business, or go to school in Barrie, regarding the proposed sites selected by the Committee. For highlights of the SCS Site Selection Advisory Committee process and meetings, see SCS Site Selection Advisory webpage.

The proposed sites are:

- 31 Toronto Street, Barrie (back building on the lot)
- 110 Dunlop Street West, Barrie (Unit 4, back of building)

PURPOSE

The key purpose of the community survey is to consult with the people who live, work, own a business, and/or go to school in Barrie regarding:

- 1. What are the potential benefits of a supervised consumption site at each of the proposed locations?
- 2. What concerns are there regarding a supervised consumption site at each of the proposed locations and what measures can be taken to address them?

The results will be used to inform the application process for an SCS in Barrie, as well as further community consultations with the Barrie community, including mitigation strategies that could be implemented to address identified concerns.

ABOUT THE DATA COLLECTION

Individuals who live, work, own a business or go to school in Barrie were invited to participate in an online survey through CheckMarket®¹ from October 7, 2020 to October 30, 2020. Please see Appendix A for all data collection tool. Upon request, those who wished to complete the survey via paper, were able to receive a paper copy of the survey to be completed and mailed back to the Simcoe Muskoka District Health Unit, which were then entered into the online survey.

In total, 1,471 responses to the public survey were received. Since the target population was only those individuals who live, work, own a business, or go to school in Barrie, 44 respondents were screened out as not meeting this criteria and their responses were excluded from the results. As well, 226 responses were excluded due to incomplete surveys. Therefore, 1,200 responses to the public survey were included in the results for this report.

Due to the survey being a convenience sample, the results obtained from this survey cannot be generalized to the population of Barrie. As such, the results describe only the opinions of those who chose to complete the survey and cannot be assumed to represent the opinions of all people who live, work, own a business, or go to school in Barrie, or of a particular area of Barrie, where reported.

ANALYSIS

Data analysis was completed using Microsoft Excel 2013 software and QSR International's NVivo 12 Plus² software. Frequencies and proportions were calculated for each close-ended question. For qualitative questions, QSR International's NVivo 12 Plus² software was used for

thematic analysis. Comments could be themed into more than one category, and only comments that pertained to the question asked were included in the analysis.

Using postal codes provided, results were also analyzed by respondents by ward (see <u>Appendix C</u>), with an emphasis on Ward 2 where the proposed locations are found, and by respondents within 250 m of the proposed locations. Results were also analyzed by those who live, work, own a business, or go to school in Barrie (see <u>Appendix B</u>).

RESPONDENT PROFILE





Figure 1 Respondents Who Live, Work, Own a Business or Go to School in Barrie

Overall, 1,200 respondents were included in the results below. The majority of these respondents indicated that they live in Barrie (88.9%, n=1067), while 62.1% (n=745) indicated they work in Barrie. A smaller percentage of respondents (16.5%, n=198) indicated they own a business in Barrie, while 8.9% (n=107) indicated they go to school in Barrie. See Figure 1.

Respondents were also provided the opportunity to provide a postal code for where they live, work, own a business, or go to school in Barrie. They were asked to choose the postal code that they felt is most impacted by the proposed locations. This question was not mandatory, and was up to the respondent to provide this information. Overall, 1,142 respondents provided a postal code, with 97.7% (n=1,116) indicating a postal code within the City of Barrie. Of those who provided a postal code within the City of Barrie, 441 respondents provided a postal code within Ward 2, and 63 respondents provided a postal code within 250 m of the proposed locations.

These respondents cover a range of age groups; 12.3% (n=141) were 16 to 24 years old, 26.0% (n=299) were 25 to 34 years old, 23.7% (n=273) were 35 to 44 years old, 15.7% (n=181) were 45 to 55 years old, and 19.8% (n=228) were 55 years and older. A small percentage of respondents (0.2%, n=2) were under 16 years old, and 2.3% (n=26) did not answer this question. See Figure 2.

RESULTS

Respondents were asked to indicate which site they are completing the survey for, with the ability to provide input for one or both sites. Of the 1,200 respondents, 997 respondents (83.1%) provided their feedback regarding 31 Toronto Street, Barrie, and 953 respondents (79.4%) provided their feedback regarding 110 Dunlop Street West, Barrie, Unit 4. The questions asked for each proposed site were the same.

Respondents Located Within Ward 2

Of the 441 respondents who provided a postal code within Ward 2, 368 respondents (83.4%) provided their feedback regarding 31 Toronto Street, Barrie, and 352 respondents (79.8%) provided their feedback regarding 110 Dunlop Street West, Barrie, Unit 4.

Respondents Located Within 250 m of Proposed Locations

Of the 63 respondents who provided a postal code within 250 m, 53 respondents (84.1%) provided their feedback regarding 31 Toronto Street, Barrie, and 44 respondents (69.8%) provided their feedback regarding 110 Dunlop Street West, Barrie, Unit 4.

31 Toronto Street, Barrie (Back Building of the Lot)

As indicated previously, 997 respondents provided their feedback regarding a supervised consumption site at 31 Toronto Street, Barrie (back building of the lot).

Potential Benefits of a Supervised Consumption Site at 31 Toronto Street, Barrie (Back Building of the Lot)

Respondents were initially asked what they perceived to be benefits of having a supervised consumption site at 31 Toronto Street, Barrie. The top five benefits identified by respondents who provided feedback on this site include:

- reduce risk of injury and death from drug overdose (66.9%, n=662)
- reduce public use on streets or in parks and washrooms (66.2%, n=655)
- fewer used needles on the streets and in parks (65.9%, n=652)
- connect people who use drugs or their family members with health, treatment and social services (63.3%, n=626)
- reduce risk of diseases such as HIV, Hepatitis B and Hepatitis C (63.2%, n=625)

Additional potential benefits identified by respondents can be found in Figure 3.

Almost one out of four respondents who provided feedback on this site (24.6%, n =243) indicated that they do not think there are any benefits to having an SCS in this location, while a small percentage of respondents who provided feedback on this site (3.8%, n=38) indicated "other" potential benefits of an SCS at this location. Of these respondents, 15 respondent comments were not applicable as they did not identify any additional benefits. Other additional benefits identified by 23 respondents include:

- 31 Toronto Street, Barrie is closer to the downtown area where there is high drug use. Also this location is less visible from the public (n=6)
- makes for a better community, because it makes for a community that serves all people and is more inclusive (n=5)

- educates the community on harm reduction, self-care, and continues the discussion on drug use in order to normalize it (n=4)
- provides a safe place for potential clients of the SCS (n=4)
- reduces crime in the area, such as violence against women, assault, theft, etc.(n=2)
- provides support to other services by reducing the pressure front-line workers may be currently experiencing (n=1)
- cost saving (n=1)

Respondents Located Within Ward 2

368 respondents who provided a postal code located in Ward 2 provided feedback regarding an SCS at 31 Toronto Street, Barrie. The top three potential benefits identified by these respondents was similar to the overall respondents:

- Reduce risk of injury and death from drug overdose (59.5%)
- Reduce public use on streets or in parks and washrooms (58.7%)
- Fewer used needles on the streets and in parks (58.1%)

A slightly larger percentage of these respondents indicated that they did not think there are any benefits to having an SCS in this location when compared to the overall respondents (30.9% vs. 24.6%)

Respondents Located Within 250 m of Proposed Locations

53 respondents who provided a postal code located within 250 m of the proposed locations provided feedback regarding an SCS at 31 Toronto Street, Barrie. The potential benefits identified by these respondents was slightly different to the overall respondents:

- Fewer used needles on the streets and in parks (44.2%)
- Reduce risk of injury and death from drug overdose (42.3%)
- Reduce public use on streets or in parks and washrooms (42.3%)

A larger percentage of these respondents also indicated that they did not think there are any benefits to having an SCS in this location when compared to the overall respondents (42.3% vs. 24.6%)

Concerns of a Supervised Consumption Site at 31 Toronto Street, Barrie (Back Building of the Lot)

Respondents who provided feedback on 31 Toronto Street, Barrie were then asked to identify their concerns regarding an SCS at this location. The top five concerns identified by respondents who provided feedback on this site include:

- safety of community members (43.1%, n=427)
- more people who use drugs in the neighbourhood (42.3%, n=419)
- impact on neighbourhood cleanliness or quality of life (41.1%, n=407)
- impact on businesses or profits (39.9%, n=395)

more drugs being sold or trafficked in the area (39.0%, n=386)




Figure 4: 31 Toronto St, Barrie: Respondents Concerns about an SCS at This Site

Additional concerns raised by the general public are found in Figure 4.

One in three respondents who provided feedback on this site (33.0%, n=327) indicated that they have no concerns with a supervised consumption site at 31 Toronto Street, Barrie. A small percentage of respondents (4.8%, n=48) indicated "other" concerns that they have regarding a supervised consumption site at 31 Toronto Street, Barrie. Of these respondents, 10 respondent comments were not applicable as they did not identify any additional concerns. Other concerns identified by 38 respondents include:

- 31 Toronto Street, Barrie being too close to businesses, residential areas, an elementary school, parks, the waterfront, and community services such as the YMCA or Kinark.
 Also, it being an unsafe location due to the location on the property, with no available parking, a place for clients to line up or congregate safely, and may be less accessible for those who need it most (n=13)
- more stigmatization of those who access the SCS, and being targeted and harmed (n=10)

- funding concerns, such as increases to Barrie tax payers, and long-term funding for the SCS (n=3)
- concentrating services all in one location, such as methadone clinics, treatment centres, boarding homes (n=3)
- negative effects an SCS can have on close vulnerable populations, such as risk recovery center patients, women in crisis, or those seeking addiction recovery, support, or counselling (n=3)
- concerns regarding the services being provided to clients, such as no longer having the services available if the SCS were to close, not providing enough services to clients to help them become addiction free, or for mental health and addictions (n=3)
- lack of understanding of an SCS within the community (n=2)
- an SCS is only a part measure to the drug use problem (n=1)
- an increase in overdoses and/or deaths (n=1)

Respondents Located Within Ward 2

Similar to overall respondents, those who provided a postal code located within Ward 2 indicated the following top 3 concerns of an SCS in this location:

- Safety of community members (53.3%)
- More people who use drugs in the neighbourhood (51.4%)
- Impact on neighbourhood cleanliness or quality of life (49.7%)

A slightly lower percentage of these respondents (27.3%) indicated that they had no concerns with an SCS at this location as compared to the respondents overall.

Respondents Located Within 250 m of Proposed Locations

Of those who provided a postal code within 250 m of the proposed locations, the top three concerns were slightly different than those indicated by the overall respondents:

- More people who use drugs in the neighbourhood (62.3%)
- Safety of community members (60.4%)
- Impact on business or profits (54.7%)
- More drugs being sold or trafficked in the area (54.7%)

A lower percentage of these respondents (22.6%) had no concerns with an SCS at this location as compared to respondents overall.

Mitigation Strategies to Address Concerns of a Supervised Consumption Site at 31 Toronto Street, Barrie (Back Building of the Lot)




Figure 5: 31 Toronto St, Barrie: Respondents Identified Strategies to Address Concerns

Three of five respondents who provided feedback on this site (60.2%, n=580) indicated that to address the concerns identified above there must be an evaluation of services to see what is working and what is not, and share the results with the community to take action. 53.1% (n=511) indicated the need to provide the community with information about the goals of SCSs

and how they can help the community. 52.9% (n=509) indicated there needs to be an increase in clean-up of publicly discarded needles, 46.0% (n=443) indicated that there needs to be an increase in security in the area, and 45.3% (n=436) indicated there has to be ongoing ways for community feedback and engagement on the SCS. Less than 10% of respondents (8.7%, n=84) did not have any suggestions to address these concerns. See Figure 5.

Additional strategies were mentioned by the 16.3% (n=157) of respondents who selected "other". Of these respondents, 9 respondent comments were not applicable as they did not provide any additional strategies. Other additional strategies, as identified by 148 respondents, include:

- choosing a different location besides either of the proposed sites, with some respondents providing site suggestions, such as (n=44)
 - o utside of downtown and away from businesses (n=22)
 - not located near residential areas or schools (n=7)
 - in an industrial/commercial area (n=5)
 - near the hospital, police stations or to the David Busby Centre (n=3)
 - located away from specific services, such as children's services or methadone recovery centre. (n=2)
 - o a building that has more room for services (n=1)
- not having a supervised consumption site located anywhere in Barrie (n=44)

- providing other services besides a supervised consumption site, such as rehabilitation and treatment services, low income housing supports, food supports, mental health and addiction services (n=32)
- providing services alongside the supervised consumption site, such as providing treatment and rehabilitation, mental health and addictions services, increased safe supply, ensuring the SCS is maintained and kept safe (n=12)
- providing education to the community on addictions, benefits of an SCS, and drug use (n=7)
- enforcing the law for those who are using and/or selling drugs (n=7)
- encourage drug users out of Barrie (n=5)
- make clients accountable for the SCS location, having them contribute to the safety and aesthetics of the space, and having them involved in the success of the site (n=2)
- discontinue the SCS if, after a few months of implementation, there are no positive outcomes for clients or the community (n=2)
- provide ongoing communication, such as weekly updates from the Mayor, or regular updates directly to the surrounding community (n=2)
- provide supports to those in the community in close proximity to the SCS, such as reimbursements to home owners (n=1)
- measures to discourage loitering similar to what has been done at the Barrie Public Library (n=1)

Respondents Located Within Ward 2

Similar to respondents overall, of those who provided a postal code located within Ward 2. The top ways to address concerns indicated above are:

- Evaluate the services to see what is working and what is not, share results with the local community to take action (58.4%)
- Increase clean-up of publicly discarded needles (50.8%)
- Provide the local community with information about the goals of supervised consumption sites and how they can help the community (46.4%)

Respondents Located Within 250 m of Proposed Locations

Respondents who provided a postal code located within 250 m of the proposed locations identified slightly different ways to address their concerns indicated previously, such as:

- Increase clean-up of publicly discarded needles (45.1%)
- Increase security in the area (45.1%)
- Evaluate the services to see what is working and what is not, share results with the local community to take action (43.1%)
- Have ongoing ways for community feedback and engagement on the SCS (33.3%)

Additional Comments Regarding a Supervised Consumption Site at 31 Toronto Street, Barrie (Back Building of the Lot)

Respondents who provided feedback on 31 Toronto Street, Barrie were given the opportunity to comment or suggestions about an SCS at this site. Overall, 32.8% (n=327) of these respondents provided additional comments or suggestions. Of these comments, 33.3% (n=109) comments were in support of an SCS regardless of the proposed locations, while 18.3% (n=60) comments were in opposition of an SCS being opened anywhere in Barrie.

More specifically, respondents used this opportunity to reiterate suggestions to mitigate concerns of an SCS at this location (37.9% of the additional responses, n=124), such as:

- choosing a different location for an SCS, with site suggestions as follows: (n=54):
 - o outside of the downtown core
 - o in a building that is more accommodating, safer, and easily accessible
 - o near the hospital, police stations or near the busby centre
 - o in a commercial/industrial area
 - o away from residential areas, parks, schools, or services for youth
 - Mulcaster or the Wellington location.
- provide other services besides an SCS, such as rehabilitation and treatment services, or mental health and addiction services (n=31)
- provide services alongside or within the SCS, such as transit subsidy for users, counselling and addiction services, mental health services, making sure the site is accessible, and providing referrals to local organizations and housing (n=17)
- ongoing communication, education, and engagement with the community, such as providing statistics, benefits of an SCS, or having a community outreach employee to host public events (n=12)
- increase security and police presence at the location of the SCS to increase safety for the surrounding community and for potential clients of the SCS (n=11)
- ensure the upkeep of the SCS, having increased lighting, ensuring cleanliness, offering safe supply, making it a welcoming place for clients, and having clients participate in maintaining the site and surrounding area (n=7)
- utilize 110 Dunlop street west, Barrie as the site for an SCS, since it is more accessible, closer to services downtown, and a less public location (n=5)
- evaluate the SCS, such as a cost-benefit analysis, and having a 1 year pilot to see if there are benefits for clients and the community (n=4)

- keeping records of those who use the site (n=1)
- support the local community, such as increases in community funding (n=1)

Respondents also used this opportunity to reiterate their concerns of an SCS in Barrie and at this location (35.5% of the additional responses, n=116), such as:

- negative effect an SCS would have on the local community, including businesses located downtown, and that an SCS would negatively impact the revitalization of downtown that is being implemented (n=53)
- the location of the proposed sites being too close to a highly residential areas, parks, schools, social services and businesses (n=34)
- an SCS encouraging/enabling drug use and bringing more people who use drugs to the area (n=29)
- an SCS is not a solution to the drug and addiction issues occurring in Barrie (n=14)
- concentrating social services downtown, such as food banks and addiction services, which is having a negative impact on downtown (n=10)
- negative effect of an SCS on vulnerable populations in the area, such as those using counselling and addiction services, those seeking rehabilitation services, and people who use drugs who may be targeted further (n=8)
- lack of the effectiveness of an SCS for clients and the community, such as lack of safety for users and no reduction in use of emergency services (n=5)
- concerns about the safety of children and youth who are in close proximity to the site (n=5)
- lack of use of the SCS by people who use drugs in their homes or in general (n=3)

Respondents also used this opportunity to reiterate some of the benefits of having an SCS in Barrie (14.7%, n=48), such as:

- an SCS saves lives, reduces the number of drug related deaths and overdoses (n=14)
- 31 Toronto Street, Barrie is a good location because this close to those who use drugs, the proximity to community services, businesses and residential areas, and the accessibility of the site (n=11)
- an SCS provides support and compassion to those in vulnerable situations (n=10)
- positive impact on the community by increasing community safety by reducing drug use and hazardous garbage on the streets, and reducing crime (n=8)
- connecting potential clients to the services and supports they require (n=7)
- increase safety for people who use drugs (n=3)
- cost savings of having an SCS, which would reduce the costs for other services (n=2)
- provides education for the community on the importance of harm reduction (n=1)

110 Dunlop Street West, Barrie, Unit 4 (back of building)

As indicated previously, 953 respondents provided their feedback regarding a supervised consumption site at 110 Dunlop Street West, Barrie, Unit 4 (back of building).

Potential Benefits of a Supervised Consumption Site at 110 Dunlop Street West, Barrie, Unit 4 (back of building).

Similar to the question asked for the previous proposed site, respondents who provided feedback for 110 Dunlop St W, Barrie, identified potential benefits of a supervised consumption site at this location. The top five potential benefits identified include:

- reduce public drug use on streets or in parks and washrooms (68.4%, n=646)
- reduce risk of injury and death from drug overdose (68.0%, n=643)
- connect people who use drugs or their family members with health, treatment and social services (65.2%, n=616)
- reduce risk of diseases such as HIV, Hepatitis B and Hepatitis C (65.0%, n=614)
- fewer used needles on the streets and in parks (64.8%, n=612)




Figure 7: 110 Dunlop St. W, Barrie: Potential Benefits of a Supervised Consumption Site at This Location

Additional potential benefits identified by respondents can be found in Figure 7.

One out of four respondents who provided feedback on this site (25.0%, n = 236) indicated that they do not think there are any benefits to having an SCS in this location, while a small

percentage of respondents who provided feedback on this site (2.1%, n=20) indicated "other" potential benefits of an SCS at this location. Of these respondents, 6 respondent comments were not applicable as they did not identify any additional benefits. Other additional benefits identified by 14 respondents include:

- 110 Dunlop Street West, Barrie is farther away from the waterfront, and not in an area typically visited by families and tourists. This location is also easy to access and located in an area where there are high numbers of people who use drugs (n=4)
- feeling of safety and a safe place for people who use drugs (n=3)
- reduced crime, such as violence against women, assault, theft, especially crimes connected to drug use (n=3)
- increased public education on drug use, and safe use of drugs (n=1)
- provides support for other frontline workers who are currently working with this vulnerable group (n=1)
- reduced costs for healthcare and police services (n=1)

Respondents Located Within Ward 2

352 respondents who provided a postal code located in Ward 2 provided feedback regarding an SCS at 110 Dunlop Street West, Barrie, Unit 4. The top three potential benefits identified by these respondents was slightly different than those who provided feedback on 31 Toronto Street, Barrie:

- Reduce public drug use on streets or in parks and washrooms (60.8%)
- Reduce risk of injury and death from drug overdose (60.8%)
- Reduce risk of diseases such as HIV, Hepatitis B and Hepatitis C (57.1%)

A slightly larger percentage of these respondents indicated that they did not think there are any benefits to having an SCS in this location when compared to the overall respondents (31.1% vs. 25.0%)

Respondents Located Within 250 m of Proposed Locations

44 respondents who provided a postal code located within 250 m of the proposed locations provided feedback regarding an SCS at 110 Dunlop Street West, Barrie, Unit 4. The potential benefits identified by these respondents was slightly different to those who provided feedback on 31 Toronto Street, Barrie. A similar percentage of these respondents indicated the following three potential benefits to an SCS at this location:

- Reduce public drug use on streets or in parks and washrooms (47.6%)
- Reduce risk of injury and death from drug overdose (47.6%)
- Fewer used needles on the streets and in parks (47.6%)

A larger percentage of these respondents also indicated that they did not think there are any benefits to having an SCS in this location when compared to the overall respondents (42.9% vs. 25.0%)

Concerns of a Supervised Consumption Site at 110 Dunlop Street West, Barrie, Unit 4 (back of building)

Respondents who provided feedback on 110 Dunlop Street West, Barrie were then asked to identify their concerns regarding an SCS at this location. The top five concerns identified by respondents who provided feedback on this site include:

- safety of community members (42.8%, n=398)
- impact on businesses or profits (42.2%, n=392)
- impact on neighbourhood cleanliness or quality of life (41.4%, n=385)
- more people who use drugs in the neighbourhood (40.6%, n=378)
- more drugs being sold or trafficked in the area (37.1%, n=345)




Figure 8: 110 Dunlop St. W, Barrie: Respondents Concerns about an SCS at This Location

Additional concerns raised by the general public are found in Figure 8.

35.3% (n=328) of respondents who provided feedback on this site indicated that they have no concerns with a supervised consumption site at 110 Dunlop St. W, Barrie. A small percentage of respondents (3.9%, n=36) indicated "other" concerns that they have regarding a supervised consumption site at 110 Dunlop Street West, Barrie. Of those respondents, 10 respondent comments were not applicable as they did not identify any additional concerns. Other concerns identified by 26 respondents include:

- increased stigmatization of potential clients who use the SCS site, and may be targeted negatively (n=10)
- 110 Dunlop Street West, being in close proximity to the park, a school, the waterfront, YMCA youth services, and dental office (n=7)
- having a negative impact on vulnerable populations, such as clients of the recovery centre nearby (n=4)
- concentration of addiction services in one area, such as addiction services, or methadone clinics (n=4)
- an SCS being only a part measure solution to the drug problem in Barrie (n=3)
- lack of use of the SCS (n=1)

- accessibility of the SCS, and if they are easy to find and get to (n=1)
- increased overdoses and/or deaths (n=1)

Respondents Located Within Ward 2

Similar to those respondent who provided feedback on 31 Toronto Street, Barrie, those who provided a postal code located within Ward 2 indicated the following top 3 concerns of an SCS in this location:

- Safety of community members (49.9%)
- Impact on businesses or profits (49.3%)
- Impact on neighbourhood cleanliness or quality of life (48.7%)

A lower percentage of these respondents (31.0%) indicated that they had no concerns with an SCS at this location as compared to the respondents overall.

Respondents Located Within 250 m of Proposed Locations

Of those who provided a postal code within 250 m of the proposed locations, the top three concerns were slightly different than those who provided feedback for 31 Toronto Street, Barrie:

- Impact on businesses or profits (61.9%)
- Impact on neighbourhood cleanliness or quality of life (59.5%)
- More people who use drugs in the neighbourhood (59.5%)
- More drugs being sold or trafficked in the area (57.1%)

A lower percentage of these respondents (21.4%) had no concerns with an SCS at this location as compared to respondents overall.

Mitigation Strategies to Address Concerns of a Supervised Consumption Site at 110 Dunlop Street West, Barrie, Unit 4 (back of building)




Figure 9: 110 Dunlop St. W, Barrie: Respondents Identified Strategies to Address Concerns

About three of five respondents who provided feedback on this site (59.7%, n=546) indicated that to address the concerns identified above there must be an evaluation of services to see what is working and what is not, and share the results with the community to take action. 56.7% (n=518) indicated the need to provide the community with information about the goals of SCSs and how they can help the community. 54.3% (n=496) indicated there needs to be an increase in clean-up of publicly discarded needles, 47.8% (n=437) indicated there has to be ongoing ways for community feedback and engagement on the SCS, and 46.3% (n=423) indicated that there needs to be an increase in security in the area. 10.1% (n=92) of respondents did not have any suggestions to address these concerns. See Figure 9.

Additional strategies were mentioned by the 11.9% (n=109) of respondents who selected "other". Of these respondents, 1 respondent comments was not applicable as they did not provide any addition strategies to mitigate the previous concerns listed. Other additional strategies, as identified by 108 respondents, include:

- not having a supervised consumption site located anywhere in Barrie (n=42)
- choosing a different location besides either of the proposed sites, with some respondents providing site suggestions, such as (n=34)
 - o outside of downtown core (n=17)
 - away from recovery centers, businesses, the waterfront, parks, and other social services (n=6)
 - o find a more suitable location than the proposed site (n=5)
 - near the hospital, police station or city hall (n=5)
 - o in the industrial area (n=1)
- provide other services besides an SCS, such as focusing on treatment, counselling, rehabilitation services, housing, food security, and education (n=23)
- provide services alongside an SCS, such as mental health, and rehabilitation to help those stop using drugs (n=6)
- enforcing the law for those who are using and/or selling drugs (n=4)

- ensure a safe space for an SCS, including maintaining cleanliness, increasing lighting and cameras, as well as ensure clients remain on property after using (n=3)
- have a trial run of an SCS in Barrie, and if problems arise then it will be closed (n=2)
- provide ongoing communication to educate City council (n=1)
- encourage those who use drugs out of Barrie (n=1)

Respondents Located Within Ward 2

Similar to respondents who provided feedback for 31 Toronto St. Barrie, of those who provided a postal code located within Ward 2, the top ways to address concerns indicated above are:

- Evaluate the services to see what is working and what is not, share results with the local community to take action (60.2%)
- Increase clean-up of publicly discarded needles (54.2%)
- Provide the local community with information about the goals of supervised consumption sites and how they can help the community (53.0%)

Respondents Located Within 250 m of Proposed Locations

Respondents who provided a postal code located within 250 m of the proposed locations identified similar ways to address their concerns indicated previously as those respondents who provided feedback from 31 Toronto Street, Barrie, such as:

- Increase clean-up of publicly discarded needles (58.1%)
- Increase security in the area (53.5%)
- Evaluate the services to see what is working and what is not, share results with the local community to take action (41.9%)
- Have ongoing ways for community feedback and engagement on the SCS (41.9%)

Additional Comments Regarding a Supervised Consumption Site at 110 Dunlop Street West, Barrie, Unit 4 (back of building)

Respondents who provided feedback on 110 Dunlop Street West, Barrie were given the opportunity to comment or make suggestions about an SCS at this site. Overall, 24.0% (n=229) of these respondents provided additional comments or suggestions. Of these comments, 24.0% (n=55) were in support of an SCS regardless of the proposed locations, while 21.8% (n=50) were in opposition of an SCS being opened anywhere in Barrie.

More specifically, respondents reiterated suggestions to mitigating concerns of an SCS at this location (38.9%, n=89):

- choose a different location for an SCS, with site suggestions as follows (n=35):
 - outside of downtown core
 - o close to the hospital, police station, or near the Busby Centre
 - away from residential areas, businesses, social services such as the YMCA, and parks
 - In an industrial or commercial area
 - Mulcaster location
 - in a building that is more accommodating
- provide other services besides an SCS in Barrie, such as treatment and rehabilitation services, food security, affordable housing, an addictions mobile response team, mental health services, and poverty reduction (n=27)
- provide services alongside an SCS such as transit subsidy or transportation for users, vocational services, mental health and addiction services, treatment and rehabilitation services, counselling services, basic life skills classes, and housing supports (n=11)
- ensure the SCS is easily accessible for potential clients, increased lighting, cleanliness, safe supply, and providing services only to those who want to stop using drugs (n=9)
- increase security and police presence at an SCS and in the surrounding community (n=8)
- provide ongoing communication, education, and engagement with community, such as more transparency around proposed SCS locations, benefits of an SCS for potential clients and the community, a paid community outreach employee to host public events (n=8)
- 31 Toronto Street, Barrie would be the better location (n=4)
- evaluate the impacts of an SCS on the local community, and its effect on the opioid problem (n=3)

• provide support for the local community, including tenants within the affected area, allowing them to break their lease (n=2)

Respondents also used this opportunity to reiterate concerns of having an SCS at this location or in Barrie (37.6%, n=86):

- negative impact on the local community, including businesses, and will go against the revitalization of the downtown core, making problems worse downtown (n=38)
- 110 Dunlop Street West is too close to a residential area, businesses, the park, the bus station, social services, such as assisted living centres and the YMCA, and the waterfront (n=25)
- encouraging more drug use and attracting more people who use drugs to the area (n=21)
- concentrating many social services downtown, such as food banks, shelters, and addiction services, which is having a negative impact on downtown (n=15)
- an SCS does not address the drug problem in Barrie (n=8)
- concerns regarding the potential clients of an SCS, such as those using in homes not using the site, clients being targeted, and what happens to clients once they are at an SCS (n=6)
- negative impact on vulnerable populations located near the site, such as those using the methadone clinic, and those living in poverty (n=2)
- continued funding of an SCS once opened (n=1)

Respondents also reiterated benefits to having an SCS at this location (18.8%, n=43):

- 110 Dunlop Street West, Barrie is a good location, because it is in close proximity to
 other services, farther away from residential areas, located close to where people are
 using drugs, more accessible, larger building, in need of less renovations, and looks
 more like a business rather than a house (n=21)
- an SCS saves lives, reduces the number of drug related deaths and overdoses (n=15)
- an SCS provides support and compassion to those in vulnerable situations (n=8)
- provides a safe space for people who use drugs (n=7)
- cost savings of having an SCS (n=1)
- provides support to the local community, such as front-line workers (n=1)
